
**Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

1. The bills from Sep'2019 to Dec'2019 are to be revised on actual meter readings by taking the IMR as "0001" and FMR as "0145" as per Regulation 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019
2. The average bills served to the complainant from Sep'2017 to Aug'2019 (Two years) are to be revised as per the actual average of consumption derived from the date of meter change to Mar' 2020 of new meter as per Section 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
3. Any adjustments done during the revision period are also to be taken in to consideration.
4. DPS charged on the wrong bills are also to be withdrawn.
