OPPOSITE PARTY

GIST OF THE CASE

The Complaint petition filed in the name of Sri Manoj Kumar Debta, Mahatam Pada, Barpali, represented by Sobhumyum Debta objected about wrong provisional adjustment for the period from Dec 2006 to July 2007. Hence, the complainant prayed before the Forum for an efficacious remedy for resolution of the billing dispute.

SUBMISSION OF OPPOSITE PARTY

The Opposite Party submitted the ledger copies from Oct o6 to Sept 24, the Physical Verification Report dt. 22.10.24 and the written submission to the case. In reply to the case, the Opposite Party submitted that, the initial date of power supply to the complainant was effected on 14.10.2006. The Opposite party urged before the Forum to issue order as deemed fit for revision of the provisional energy bills raised from Dec 2006 to July 2007.

OBSERVATION

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing Consumer No-5151-0101-0392, having CD-02KW, under LT-Domestic category, under ESO, Barpali-I. On examining the case in detail, it was observed that, the initial date of power supply to the complainant was effected on 14.10.2006 with meter Sl No. "17525A". From the ledger abstract it is found that, the first energy bill was generated on Oct o6 on actual basis for 99 bill units with CMR "102". Then, in the month of Nov o6, actual energy bill was raised for 135 bill units with CMR "237" KWH. Thereafter, from Dec o6 to July 07, the energy bills were raised on provisional basis @ 135 units/month. In the month of Aug 07, the energy bill was raised on actual basis for 420 bill units with CMR "657" KWH . It is found from the ledger abstract that, an amount of Rs. 458.64/- has been auto adjusted (withdrawn) in the billing month of Aug 07.

However, it was revealed that, on entry of advanced meter reading in Aug 07 billing, previous provisional bills so charged from Dec 06 to July 07 were not fully adjusted. Therefore, the provisional bills so raised during the aforementioned period are required to be revised and adjusted as per actual meter reading basis to redress the grievances of the complainant.

ORDER

Considering the documents and statements submitted by both the parties and agreed upon at the time of hearing, the Forum hereby passes orders in consonance with regulations of the OERC Distribution (Conditions of Supply) Code 2019.

- 1) The Opposite Party is directed to revise and reassess the energy bills charged to the complainant for the period from Dec 06 to Aug 07, on the basis of actual monthly average consumption to be derived by taking IMR as KWH "237" as on Dec 06 and FMR as KWH "657" as on Aug 07 as recorded in meter Sl No. "17525A", duly adjusting the bill revision made earlier and/or, the benefit arising out of the OTS Scheme, if any.
- 2) The Opposite Party is advised to serve the revised energy charges bill with revised due date within 30 days from the issue of this Order, upon revision of previous bills, if any, payable by the consumer.
- 3) The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill, to which the complainant is liable to pay.

The Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order.

Accordingly, the case is disposed of.
