### GIST OF THE CASE / PETITION FILED

The Complaint petition filed in the name of Sri Sadram Podh, represented by Sri Hemsagar Podh, objected about abnormal energy bills raised from the month of Dec 2022 to Sept 2023 & prayed before the Forum to direct the Opposite Party to resolve the billing dispute accordingly.

#### SUBMISSION OF OPPOSITE PARTY

The Opposite Party submitted the Physical verification Report dt. 23.10.2024, ledger abstract from Jan 08 to Sept 24 and the written submission to the case. In reply to the case, the Opposite Party submitted that, the initial date of power supply to the complainant was effected on 17.12.2007. The energy bills were raised on actual/provisional/average basis from time to time till Dec 22. Thereafter, from Apr 23 to Feb 24 the energy bills were raised on Provisional/Average basis. One new meter bearing Sl No. "TWSP51152576" was installed in the complainaNt's premises on dt. 29.03.24. But the meter was charged in the month of Aug 24. Hence the Opposite Party urged before the Forum to issue order as deemed fit.

## OBSERVATION / FINDINGS OF THE FORUM

The case is perused with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing Consumer No-5154-1208-0592, having CD-01 KW, under LT-Domestic category, under ESO-Jharbandh. The date of initial power supply to the complainant was effected on 17.12.2007. From the ledger abstract it is found that, the energy bills were raised on actual/provisional/average basis from Jan 08to Dec 2022. The energy bill was raised on actual basis with CMR "31117.73" KWH. Thereafter from Jan 23 to Mar 23, no billing records is found. Again, from Apr 23 to Feb 24, the energy bills were raised on provisional/average basis. One new meter bearing Sl No. "TWSP51152576" was installed in the complainant's premises and updated in billing database in the month of Mar 24. But the meter status is mentioned as "not in use" till Aug 24. In the month of Sept 24, energy bill was raised on actual basis for "19" bill units with CMR "49" recorded for the month. The Physical Verification Report dt. 23.10.2024 indicated that, the existing meter having Sl no. "TWSP51152576" has found in running condition with advanced meter reading recorded as KWH "000096".

As per the complaint filed by the complainant regarding abnormal bill raised from Sept 2023, the Forum on scrutinizing the records construed that, the above period bills raised from Provisional/average basis due to defective meter, are to be revised accordingly on the basis of new meter consumption as recorded in the meter Sl no. "TWSP51152576". Since the above mentioned new meter was actually line charged in the premises during the month of Aug 2024, as certified by the Opposite Party (although the exact date of charging of the meter and the reason for such delay in charging are not submitted by the Opposite Party), the period and average consumption of the same meter are to be derived considering six months actual monthly average consumption so recorded starting from Sept 2024.

#### **ORDER**

Considering the documents and statements submitted by both the parties and agreed upon at the time of hearing, the Forum hereby passes orders in consonance with regulations of the OERC Distribution (Conditions of Supply) Code 2019.

- 1. The Opposite Party is directed to revise the monthly energy bills charged from Mar 22 to Feb 24 as per Regulation 155 of OERC Distribution (Conditions of Supply) Code,2019, on the basis of actual monthly average consumption recorded in the existing meter Sl No. "TWSP51152573", so derived from the consecutive six months consumption starting from Sept 24 onwards, duly adjusting the bill revision already made earlier, and/or the benefit arising of the OTS Scheme if any.
- 2. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjusting the payments made by the complainant and ensure payment thereof.
- 3. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill, to which the complainant is liable to pay.

The Opposite party is directed to submit the compliance report to this Forum within five month from the date of issue of this order.

Accordingly, the case is disposed of.
