ORDER

Brief Facts of the Case



During the spot hearing at ESO-Bheden of Bheden Electrical Sub-division under Bargarh Electrical Division camp on 20-08-2025, the complainant appeared before the Forum whereas SDO- Bheden appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT- Domestic consumer having consumer No. 5125-2215-1044 with connected load of 1.00 KW. That the Complainant has raised objection regarding the provisional/ average billing from Dec'2021 to Apr'2025. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

1. Submission of the Complainant:

- 1. The complainant submits that, provisional/average bills have been served to him from Dec'2021 to Apr'2025 due to which high billings have been done resulted to accumulation of arrear.
- 2. He further submits that; he had made verbal complain to the respondent about the erroneous bill.
- 3. He also requested the Forum to revise the bills.

2. Reply Submission of the Respondent:

i. The respondent also agreed upon provisional/ average billing from Dec'2021 to Apr'2025 and agreed for revision of bills and submitted PVR dated 25-08-2025. However, the respondent requested the Forum to take appropriate decision as necessary.

Findings and observations of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the

relevant documents, FG and Samadhan database (Licensee's soft records) provisions of law have concluded as follows:

- a. That the complainant has been given power supply on 03-12-2021 and provisional/average bills have been served from date of power supply to Apr'2025.
- b. In the meanwhile, a new meter bearing Sl. No. TWST15105665 has been installed on 12-05-2025 in the premises of the complainant.
- c. Hence, the Forum construed that, the provisional/average bills should be revised.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

- The provisional/average bills from May'2023 to Apr'2025 (Two Years) are to be revised as per the average of six consecutive billing of new meter as per Section 155 and 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019
- 2. Any adjustments done during the revision period are also to be taken in to consideration.
- 3. DPS charged on the wrong bills are also to be withdrawn.

The Opposite party is directed to submit the compliance report to this Forum within 31-12-2025.

Accordingly, the case is disposed of.
