### ORDER

#### **Brief Facts of the Case**

During the spot hearing camp at Barpali Electrical Sub-division under Bargarin west Electrical Division on 09-09-2025, the complainant appeared before the Forum whereas SDO- Barpali appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT- Domestic consumer having consumer No. 515102110695 with connected load of 1.00 KW. That the Complainant has raised objection regarding the wrong bills served to him from Jun'2018 to Sep'2024 during the period in which no power connection has been given to him. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier on.

#### Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

#### 1. Submission of the Complainant:

- 1. The complainant submits that, wrong bills served to him from Jun'2018 to Sep'2024 during the period in which no power connection has been given to him resulted to accumulation of arrear.
- 2. He further submits that; he had made verbal complain to the respondent about the erroneous bill.
- 3. He also requested the Forum to revise the bills.

#### 2. Reply Submission of the Respondent:

- i. The respondent submitted the PVR dated 16-09-2025 with a written submission of SDO Barpali mentioning "the consumer applied soubhagya scheme and bill generated without giving power supply. On complain, power supply given in Jul'2025 after payment of Rs.1000.00."
- ii. The respondent also agreed upon wrong power supply date and agreed for revision of bills. However, the respondent requested the Forum to take appropriate decision as necessary.

#### Findings and observations of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents, FG and Samadhan database (Licensee's soft records) and provisions of law have concluded as follows:

- That, the power supply was given to the complainant on 06-06-2018 (As per FG database). That the complainant has been billed on provisional / average basis from Jun'2018 to Sep'2024. From Oct'2024, no bill has been generated showing the complainant as Ghost consumer.
- As per submission made by the respondent, that the consumer applied soubhagya scheme and bill generated without giving power supply. On complain, power supply given in Jul'2025 after payment of Rs.1000.00.
- Therefore, it is decided by the Forum that, the bills from Jun'2018 to Sep'2024 should be withdrawn.

#### **Directions of the forum**

In view of the above findings and discussions, the Forum is of the view that,

- As there was no supply available at the complainant premises, the average/provisional bills from Jun'2018 to Sep'2024 are to be withdrawn as per Section 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
- The respondent is directed to install a new meter in the premises of the complainant and to generate the electricity bill immediately.
- Any adjustments done during the revision period are also to be taken in to consideration.
- DPS charged on the wrong bills are also to be withdrawn.

The Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order.

Accordingly, the case is disposed of.
