ORDER



During the spot hearing at Bhatli Sub-division under Bargarh Electrical Division on 21-05-2026, the complainant appeared before the Forum whereas SDO-Bhatli appeared as respondent before the Forum. The complainant has lodged objection to this Forum regarding the non-functioning of borewell point from Oct'2008 due to Low voltage problem but bills are being served to him. It is also submitted by the respondent that there is no proper availability of LT line at the borewell site. The borewell point is not functioning due to low voltage and long LT line. The consumer had not seen using supply from 2008 to till date due to low voltage and long LT line. As the complainant has approached the Forum without approaching to opposite party which is coming under CHP (Complaint handing procedure) and hence, the copy of the application is enclosed herewith and keeping the application in original for maintenance of records by this Forum and the opposite party is instructed to take up the matter to resolve the grievance at their level with the direction to submit the compliance to this Forum within one month.

However, the Opposite Party is advised to resolve the case as per internal bill revision mechanism in force.

Hence the instance case petition is hereby dropped.

Accordingly, the case is disposed of.

The complainant is at liberty to approach the Forum with necessary supporting documents if the complainant is not satisfied with the action/inaction of the opposite party.
