ORDER



During the spot hearing at Bheden Sub-division under Bargarh Electrical Division on 10-06-2026, the complainant appeared before the Forum whereas SDO- Bheden appeared as respondent before the Forum. The complainant has lodged objection to this Forum regarding the false bills generated against his name from Sep'2018 to Apr'2023 which is not being used by him. It is also submitted by the respondent that power supply is not extended against consumer no. 5125-2306-0624 till date but bills have been generated on average basis. The consumer is using another power supply in the same premises through another connection bearing consumer no. 512523060169. As the complainant has approached the Forum without approaching to opposite party which is coming under CHP (Complaint handing procedure) and hence, the copy of the application is enclosed herewith and keeping the application in original for maintenance of records by this Forum and the opposite party is instructed to take up the matter to resolve the grievance at their level with the direction to submit the compliance to this Forum within one month.

However, the Opposite Party is advised to resolve the case as per internal bill revision mechanism in force.

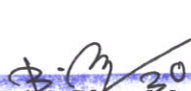
Hence the instance case petition is hereby dropped.
