ORDER



Brief Facts of the Case

During the spot hearing camp at Gaisilat section of Padampur Electrical Sub-division under Bargarh West Electrical Division on 08-12-2025, the complainant appeared before the Forum whereas SDO- Padampur appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT- Domestic consumer having consumer No. 5152-0203-0654 with connected load of 1.00 KW. That the Complainant has raised objection regarding the amount of Rs.72468.35 added in his bill in Jul'2025 for meter change assessment. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

1. Submission of the Complainant:

1. The complainant submits that, an amount of Rs.72468.35 added in his bill in Jul'2025 resulted to accumulation of arrear.
2. He further submitted that his consumption has gone up due to the two nos. AC purchased by him on 24-06-2024 and 08-07-2024. He has also submitted the tax invoice in support of his arguments.
3. He further submits that; he had made verbal complaint to the respondent about the erroneous bill.
4. He also requested the Forum to revise the bills.

2. Reply Submission of the Respondent:

- i. The respondent submitted that an amount of Rs. 72468.35 added in his bill in Jul'2025 for meter change assessment for defective period. The respondent also agreed upon that the consumer is using AC after 24-06-2024. The consumer is using 4.5 KW load after 24-06-2024 and before the mention date consumer was using 0.5 KW load. However, the

respondent requested the Forum to take appropriate decision as necessary.



Findings and observations of the Forum

Written/verbal Submissions were made by both parties and arguments were heard at length. This Forum, after hearing the parties and going through the relevant documents, FG and Samadhan database (Licensee's soft records) and provisions of law have concluded as follows:

- a. That the complainant has been given power supply on 31-03-2015 with installation of a meter bearing sl. No. 200518 and bills on actual meter readings have been served up to Feb'2018 with a monthly average consumption of 25 units. From Mar'2018 to May'2024 provisional/average bills have been served due to defective meter with a monthly average consumption of 62 units.
- b. In the meanwhile, a new meter bearing Sl. No. TWST1746102 has been installed on 25-06-2024 in the premises of the complainant. It is noted that the monthly average of new meter is 556 (six months average) units for which the respondent has made an upward assessment for the defective period and an amount of Rs. 72468.35 added in his bill in Jul'2025.
- c. But as per submission made by the complainant and agreed by the respondent that as the consumer purchased two AC on 24-06-2024 and 08-07-2024 to use, the consumption has gone up.
- d. It is also noted by the Forum that as per submission made by the respondent after 24-06-2024 the consumer using 4.5 KW load and before the mention date consumer was using 0.5 KW load.
- e. Therefore, it is decided by the Forum that the amount of Rs. 72468.35 added in his bill in Jul'2025 is to be withdrawn.

Directions of the forum

In view of the above findings and discussions, the Forum is of the view that,

1. The bill revision amount of Rs. 72468.35 for meter change assessment is to be withdrawn as per Section 157 of Odisha Electricity Regulatory Commission Distribution (Conditions of Supply) Code, 2019.
2. Any adjustments done during the revision period are also to be taken in to consideration.

3. DPS charged on the wrong bills are also to be withdrawn.
