

Brief Facts of the Case

During the spot hearing at Barpali Electrical Sub-division under Bargarh West Electrical Division camp on 29.04.2025, the complainant appeared before the Forum whereas SDO- Barpali appeared as respondent before the Forum.

Brief facts pertaining to the case are that the Complainant is a LT- General Purpose < 110KVA consumer having consumer No. 5151-0108-0177 with connected load of 01 KW. That, the Complainant has raised objection regarding disconnection since 2012. But bills were raised till 2023. He requested for revision of bills and mentions about verbal complaint being made to the respondent earlier on.

Gist of Arguments made by the Parties

Both parties were present in the hearing. The contentions made by the parties are as follows:

1. Submission of the Complainant:

- 1. The complainant submits that, the power supply to his premises was disconnected since 2012. But the energy bill ware raised till 2023.
- 2. He further submits that; he had made verbal complain to the respondent about the erroneous bill.
- 3. Upon his request, the billing has been stopped now
- 4. He also requested the Forum to revise the bills.

2. Reply Submission of the Respondent:

- i. The respondent submitted the Physical Verification Report (PVR) dated 17.05.2025 with a written submission of SDO Barpali.
- ii. The Respondent mentioned that, during verification, it was found that, the electric connection to the premises of the complainant was disconnected and the meter has no display and also the service cable was disconnected.
- iii. The Respondent submitted that , the power supply to the complainant's premises was disconnected since the year 2012, but billing was continued till the year 2023.
- iv. The respondent further submit a no dues certificate on dt. 11.08.2025 against the complainant.
- v. The respondent requested the Forum to take appropriate decision as necessary.

Findings and observations of the Forum

Written/verbal Submissions were made by both parties and arguments were BARGARH heard at length. This Forum, after hearing the parties and going through the relevant documents, FG and Samadhan database (Licensee's soft records) and provisions of law have concluded as follows:

- 1. That, the energy bills were raised against the complainant on Actual/PL/Avg basis till Jun'2023. From the month of Jul'2023 the billing is stopped.
- 2. The complainant averred that, though his supply was disconnected since the year 2012, the energy bills were being raised till the year 2023.
- 3. The Opposite Party also submitted that, the power supply to the complainant's premises was disconnected since the year 2012, but billing was continued till the year 2023.
- 4. It is observed from the billing database that, one bill revision has been carried out for the period from Jan'2012 to Jun'2023 and credit sundry for an amount of Rs. 1,70,510.16/- has been effected against the complainant account on dt. 11.08.2025.
- 5. Therefore, the Forum construed that, the grievance petition of the complainant has been redressed by the Opposite Party.

Hence, the instant case is hereby dropped.
