The Complaint petition filed by the representative consumer Shri Sanjay Harpal who is a LT-Dom. consumer availing a CD of 2 KW. He was disputed about the average bill raised from Sep-2022 to Dec-2022. He has filed his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

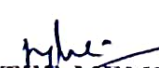
SUBMISSION OF COMPLAINANT DURING HEARING

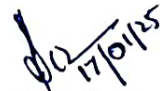
The complainant is a consumer under Agalpur section of Loisingha Sub-division. The complainant represented that he was served with average bill from Sep.-2022 to Dec.-2022 due to meter defective. For that, the total outstanding has been accumulated to ₹ 2,056.84p upto Dec.-2024. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

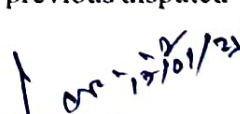
The OP appeared before the Forum with relevant record. On defence, he intimated that the consumer is a LT-Dom. consumer availing power supply since Jul.-2014. The billing dispute raised by the complainant for the average billing from Sep.-2022 to Dec.-2022 was due to meter defective for that period. A new meter with sl. no. 300065891 has been installed on 08th Jan. 2023, thereafter actual billing has been done. As the above-stated period bill has not revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 2 KW. The consumer has availed power supply since 19th Jul. 2014 and total outstanding upto Dec.-2024 is ₹ 2,056.84p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. As represented by the consumer, due to meter defective, he was served with average bills from Sep.-2022 to Dec.-2022 which needs bill revision.

The OP admitted the complaint and submitted that a new meter was installed with meter no. 300065891 on 08th Jan. 2023 and thereafter actual billing has been done. The defective billing period needs bill revision as per consumption of new meter.

During the course of hearing, the OP has admitted with the billing complaints and initiated bill revision process on the spot observing departmental guidelines. Accordingly, the monthly bill has been recalculated with the consumption and an amount of ₹ 2,096.65p is to be withdrawn from the arrear outstanding.

2. The complainant has not paid the monthly bill regularly for which the total has been accumulated to ₹ 2,056.84p upto Dec.-2024.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

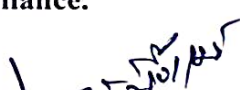
The OP was agreed with the billing dispute and revised the bill on spot and the petitioner was convinced with the proposed withdrawal amount of ₹ 2,096.65p. Hence, the Forum directed the OP to carry-out the revision proposal and must be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
