ORDER
(Dt.20.04.2026)

During Camp Court hearing at Kantabanji Sub-division Office on 18th Mar. 2026, the representative of the consumer Shri Tanu Chhatria was present & Shri Sanjay Tirkey, SDO-Kantabanji Sub-division was present as opposite party.

HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 1 KW. The complainant represented that he is getting abnormal & inflated bill from the date of power supply i.e. 27th Sep. 2022 to till date. For that inflated bill, the arrear outstanding has been accumulated to ₹ 23,104.25p upto Mar.-2026. The complainant raised dispute about the present meter accuracy and requested before the Forum for suitable revision of the bill.

The case was heard in detail.

PROCEEDING OF HEARING DATED : 18.03.2026

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Kantabanji section of Kantabanji Sub-division. The consumer represented that he has been served with abnormal & inflated bill from the date of power supply to till date and he is under apprehension that the said meter is recording excess consumption than actual consumption. The complainant raised dispute against the said period and requested before the Forum for replacement of meter and suitable revision of bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant documents. On defence, he intimated that the consumer is a LT-Dom. consumer availing power supply since Sep.-2022. The billing dispute raised by the complainant for the inflated billing with the new meter is not a genuine dispute as all bills are raised on actual meter reading basis. Hence, the petition of the complainant should be rejected.

Considering the above, the OP requested before the Forum to reject the petition of the consumer and to pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 1 KW. The consumer has availed power supply since 27th Sep. 2022 and the arrear outstanding upto Mar.-2026 is ₹ 23,104.25p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. The consumer has availed power supply since 27th Sep. 2022 with meter no. 9044297 and till date the same meter is existing with running condition. The consumer has disputed the accuracy of the meter and represented that the said meter is showing excess consumption than actual consumption.
2. In response to that, the Forum directed the complainant to deposit the required meter testing fees with the licensee within seven days and directed the OP to test the meter by the MMG team at the earliest with submission of detailed report to the Forum. The complainant has deposited the required fees on 18th Mar. 2026 vide MR no. : 44744718032604040001. The MMG team has tested the meter on 16th Apr. 2026 and submitted the report before the Forum on the same day. The abstract of the PVR is,
"During testing, it has been found that the testing result is within limit i.e. 0.57%."

The meter test conducted by MMG team and report generated on 16th Apr. 2026 has been taken into record.

3. Hence, it is concluded that the present meter i.e. meter no. 9044297 is out of error.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The accuracy of meter (meter sl. no. : 9040297) disputed by the complainant has been tested on 16th Apr. 2026 and found error is within permissible limit. Hence, the petition of the complainant regarding dispute on meter accuracy is hereby rejected and directed to clear the arrear outstanding.

Case is disposed off accordingly.
