HISTORY OF THE CASE

The Complainant is a Irrigation pumping & Agriculture. consumer availing a CD of 2.5 KW_availing power supply since Aug-2021 but billing was done since 14/01/2014. He has disputed bill generation date and submitted proof by submitting his representation to the then ESO Chhatamakhna and remark of ESO on the body of his representation regarding non availing of power supply till Dt.10.08 2021 which was further ascertained by a letter from EE, OLIC. Furthermore, he has submitted photocopy of agreement for power supply which was executed on Dt.01.09.2021. His grievances for revision of bill in GRF camp at Kushmel under ESO-Chhatamakhna was heard at spot. The complainant needs suitable bill revision by withdrawal of billing amount

PROCEEDING OF HEARING DT:10.03.2025

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Chhatamakhna Section of Sub-division No-II, Bolangir. The consumer represented that he was been served bills from Dt.14.01.2014 although he has availed power supply after execution of agreement in Sept-2021. He has produced supportive documents like agreement copy executed with Licensee, Letter of from EE, OLIC, Bolangir and verification remarks from then ESO, Chhatamakhna. The Consumer further informed that he is billed on Avg basis as the present meter status is defective and requested to advise OP for early replacement of meter. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP participated in GRF Camp with relevant documents and intimated that the consumer is a LI Pt. consumer availing power supply since Aug-2021. The billing dispute raised by the complainant regarding bill generation prior to actual power supply date is genuine. As the above-stated period bill has not been revised, bill revision is needed by way of withdrawal of bills from 14th Jan. 2014 to July-2021. Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a Irrigation consumer with a CD of 2.5 KW. The consumer has availed power supply since Aug-2021 but billed from Dt.14.01.2014. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. Meter is to be replaced immediately as the consumer is billed on Avg. basis.

2. Matter was discussed in details with both parties and OP agreed to revise bill by withdrawing billed amount upto July-2021 and complainant agreed to pay.

3. Bills are to be revised by way of withdrawal of bills from Dt.14.01.2021 to July-2021 to redress the consumer grievances.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

1. The energy bills raised to the consumer from 14th Jan. 2014 to Jul-2021 must be withdrawn as there was no power supply to the consumer premises.

2. A new tested meter is to be installed immediately as the consumer is billed on Avg Basis

3. DPS is to be levied as per OERC Regulation.

4. All sundries and adjustments are to be considered during the above revision period.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
