**ORDER**  
**(Dt.31.03.2026)**

During Camp Court hearing at Tureikela PSS on 25<sup>th</sup> Mar. 2026, the representative of the consumer Shri Dilip Kumar Sahu was present & Shri Sanjay Tirkey, SDO-Kantabanji was present as opposite party.

**HISTORY OF THE CASE**

The Complaint petition filed by the representative of the consumer Shri Dilip Kumar Sahu who is a LT-Dom. consumer availing a CD of 1 KW. He was disputed about the average bill raised from Jan-Feb/2004 to Jul-Aug/2004. He has filed his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

**PROCEEDING OF HEARING DATED : 25.03.2026**

**SUBMISSION OF COMPLAINANT DURING HEARING**

The complainant is a consumer under Tureikela Section of Kantabanji Sub-division. The complainant represented that he was served with average bills from Jan-Feb/2004 to Jul-Aug/2004 due to meter defective. For that, the total outstanding arrear has been accumulated to ₹ 23,170.41p upto Feb.-2026. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

**SUBMISSION OF OPPOSITE PARTY DURING HEARING**

The OP appeared before the Forum with relevant record. On defence, he intimated that the consumer is a LT-Dom. consumer availing power supply prior to Apr-1999. The billing dispute raised by the complainant for the average billing from Jan-Feb/2004 to Jul-Aug/2004 was due to

meter defective for that period. A new meter with sl. no. 1950688 has been installed during Sep-2004, thereafter actual billing has been done. As the above-stated period bill has not yet revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

### **FINDINGS AND ANALYSIS OF THE FORUM**

The consumer is a LT-Dom. consumer with a CD of 1 KW. The consumer has availed power supply prior to Apr-1999 and total outstanding upto Feb.-2026 is ₹ 23,170.41p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. As represented by the consumer, due to meter defective, he has been served with average bills from Jan-Feb/2004 to Jul-Aug/2004 which needs bill revision.
2. The OP admitted the complaint and submitted that a new meter has been installed with meter no. 1950688 during Sep.-2004 and thereafter actual billing has been done. The defective billing period needs bill revision as per consumption of new meter in obedience to OERC Regulation.
3. In the instant case, it is surprised that the OP has allowed the consumer to continue with defective meter for more than eight months which violates CI-155 of OERC Distribution (Conditions of Supply) Code-2019 and also attracts under Schedule-III of Guaranteed Standard of Performance of OERC Distribution (Conditions of Supply) Code. Hence, it is advised the OP to be more pro-active for replacement of defective meter within standard time as prescribed by Hon'ble OERC. Due to delay in installation of new meter, average billing was done which could have been avoided if the OP has installed the meter without delay for which it is advised to the OP to be taken care in future.
4. During the course of hearing, the OP has admitted with the billing complaints and initiated bill revision process on the spot observing departmental guidelines. Accordingly, the monthly bill has been recalculated with the consumption and an amount of ₹ 1,070.80p is to be withdrawn from the arrear outstanding.
5. The complainant has not paid the monthly bill regularly for which the total outstanding has been accumulated to ₹ 23,170.41p upto Feb.-2026.
6. On scrutiny of the documents, it is observed by the Forum that the bills raised during meter defective period needs bill revision under CI-155 & 157 of OERC Distribution Code-2019 to redress the consumer grievances.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP has agreed with the billing dispute and revised the bill on spot and the petitioner has convinced with the proposed withdrawal amount of ₹ 1,070.80p. Hence, the Forum directed the OP to carry-out the revision proposal and must be reflected in the next bill.
