HISTORY OF THE CASE

The Complaint petition filed by the consumer Shri Goutam Nag who is a LT-Dom. consumer availing a CD of 1 KW. He has disputed about the provisional & average bill raised from May-2012 to Mar-2013. He has filed his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED : 24.03.2025

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Kantabanji section of Kantabanji Sub-division. The complainant represented that he has been served with provisional & average bills from May-2012 to Mar-2013. For that disputed bill, the total outstanding has been accumulated to ₹ 18,432.66p upto Feb.-2025. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant record. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Aug-2002. The billing dispute raised by the complainant for the provisional & average billing from May-2012 to Mar-2013 was due to meter defective for that period. Thereafter power supply was disconnected from Apr-2013 to Mar-2023. On 18th Apr. 2023, reconnection has been done after installation of new meter with meter no. TW02031269, thereafter actual billing has been done. As the above-stated period bill has not been revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 1 KW. The consumer has availed power supply since 17th Aug.2002 and total outstanding upto Feb.-2025 is ₹ 18,432.66p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. As represented by the consumer, due to meter defective, he was served with average bills from May-2012 to Mar-2013 which needs bill revision.

The OP submitted that power supply to the consumer was under disconnection from Apr-2013 to Mar-2023. Power supply has been restored on 13th Apr. 2023 after installation of new meter with sl. no. TW02031269 and thereafter actual billing has been done. The defective billing period needs bill revision as per consumption of new meter.

During the course of hearing, the OP has admitted with the billing complaints and initiated bill revision process on the spot observing departmental guidelines. Accordingly, the monthly bill has been recalculated with the consumption and an amount of ₹ 6,240.37p is to be withdrawn from the arrear outstanding.

2. The complainant has not paid the monthly bill regularly for which the total has been accumulated to ₹ 18,432.66p upto Feb.-2025.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP was agreed with the billing dispute and revised the bill on spot and the petitioner was convinced with the proposed withdrawal amount of ₹ 6,240.37p. Hence, the Forum directed the OP to carry-out the revision proposal and must be reflected in the next bill. Only MMFC and statutory charges is to be charged during power supply disconnection period.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
