ORDER (Dt.23.04.2025)

HISTORY OF THE CASE

The Complaint petition filed by the representative of the consumer Smt. Puspa Chandan who is a LT-Dom. consumer availing a CD of 1 KW. She has disputed about the provisional bill raised from Jul-2016 to Aug-2017 which has not been rectified subsequently. She has filed her grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED: 19.04.2025

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Saintala section of Saintala Sub-division. The complainant represented that she has been served with provisional bills from Jul-2016 to Aug-2017 which has not been rectified till date. For that disputed bill, the total outstanding has been accumulated to ₹ 13,632.25p upto Mar.-2025. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant record. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Sep.-2014. The billing dispute raised by the complainant for the provisional billing from Jul-2016 to Aug-2017 is a genuine dispute which needs bill revision. As the above-stated period bill has not been revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 1 KW. The consumer has availed power supply since 05th Sep. 2014 and total outstanding upto Mar.-2025 is ₹ 13,632.35p. As complained by the complainant and submission of OP, it is observed by the Forum that,



As represented by the consumer, she has been served with provisional bills from Jul-2016 to Aug-2017 which needs bill revision.

The OP admitted the complaint and submitted that the provisional billing period needs bill revision to resolve the consumer grievance.

During the course of hearing, the OP has admitted with the billing complaints and initiated bill revision process on the spot observing departmental guidelines. Accordingly, the monthly bill has been recalculated with the consumption and an amount of ₹ 9,726.93p is to be withdrawn from the arrear outstanding.

The complainant has not paid the monthly bill regularly for which the total arrear 2. has been accumulated to ₹ 13,632.35p upto Mar.-2025.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP was agreed with the billing dispute and revised the bill on spot and the petitioner was convinced with the proposed withdrawal amount of ₹ 9,726.93p. Hence, the Forum directed the OP to carry-out the revision proposal and must be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
