OPPOSITE PARTY

ORDER (Dt.30.04.2025)

During spot hearing at Khaprakhol consumer camp on dt.21.04.2025 the Complainant Sri Bideshi Padhan appeared before the Forum in person whereas Sri Smarak Panigrahi, Accountant, Electrical Sub-Division, TPWODL, Patnagarh appeared as representative of opposite party.

The Complainant bearing consumer no. 912001023330 in his written petition dt.21.04.2025 disputed the abnormal and average billings done prior to installation of the existing meter. He finally requested the Forum to redress his grievance by way of a suitable bill revision.

The opposite party on the other hand submitted a billing statement concerning to the period from April'2018 to March'2025 along with a revision statement. He also requested the Forum to do the needful as deemed fit in this regard.

The Forum after going through all the relevant records placed before it observed that;

- 1. The consumer comes under Irrigation pumping & agriculture category with CD of 2.5 KW
- 2. Average basis bills having no meter are seen to have been raised during the period from the date of power supply and provisional bills from October'2022 to July'2023 and thereafter on actual basis.
- 3. A new meter bearing SL. No. TPU022167 has been installed with provisional billing which appears to have been adjusted during November'2023.
- 4. Another new meter has been replaced bearing no. TWSL39007721 on dt.18.03.2024.
- 5. A consumption of 2425 unit is seen to have been done during February'2024.

6. The arrear has gone upto Rs.14551.20 by month ending March'2025.

However, during the course of hearing the opposite party was agreed with the billing complaint and initiated bill revision process on spot after observing the departmental guidelines. Accordingly, the monthly bills have been recalculated and an amount of Rs.9852.89ps is to be withdrawn from the arrear resulting revision of average bills, obtaining subsequent six months HENT Solowlas average consumption of the new meter.

CO-OPTED MEMBER

Thus the opposite party has revised the bill and the Complainant was convinced with it having proposed withdrawal of Rs.9852.89ps.

The Forum therefore directed the opposite party to carry-out revision proposal amount to Rs.9852.89ps which needs to be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
