ORDER (Dt.29.07.2025)

The complainant has appealed before the Forum on 03rd Jul. 2025 which has been registered as Case no. 357/2025. The complainant has raised grievances about billing with two different consumers with same billed units which needs to be revised.

Accordingly, hearing date has fixed on 14th Jul. 2025 and notice was served to both the parties to remain present with supportive documents on the said date.

HISTORY OF THE CASE

The Complaint petition filed by the representative of the consumer Shri Pallav Kumar Hota who is a LT-Dom. (Poly phase) consumer availing a CD of 6 KW. He has disputed that the consumption units have been billed in two different consumers wrongly which needs to be revised. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED: 14.07.2025

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Chudapali section of Balangir division. The complainant represented that he is availing power supply though three phase meter (Meter no. TWSC59034152). There is a separate connection bearing cons. no. 9112-1128-0908 in the name of Shri Lokanath Gadtya. The consumption unit of Shri Lokanath Gadtya is being added in his bill as well as separate bill is being generated based on his monthly consumption. The complainant disputed the same and requested before the Forum for revision of bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant records. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Jul.-2024. The consumer is availing power supply at 400 volt with LT metering and a CD of 6 KW. There is another connection

in the name of Shri Lokanath Gadtya having consumer no. 9112-1128-0908 with a CD of 5 KW. At the time of extending power supply to Shri Lokanath Gadtya, wrongly the connection has been given to the outgoing side of Shri Rinku Patra, Cons. no.: 9110-0113-0696, resulting the consumption unit of Shri Gadtya is being billed against his consumer no. 9112-1128-0908 as well as 9110-0113-0696.

Considering the above, the OP requested before the Forum to consider this and allowed to deduct the billed unit of Shri Gadtya (9112-1128-0908) from the bill of Shri Rinku Patra (9110-0113-0696) and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Polyphase Dom. consumer with a CD of 6 KW. The consumer has availed power supply since 23rd Jul. 2024. As complained by the complainant and submission of OP, it is observed by the Forum that,

The consumer Shri Rinku Patra(9110-0113-0696) is availing power supply at 400 volt with meter no. TWSC59034152. Also, another consumer Shri Loknath Gadtya (9112-1128-0908) is availing power supply with meter no. TWST17775534 since 30th Oct. 2024. At the time of giving power supply to Shri Gadtya, the OP wrongly giving power supply to the outgoing side of Shri Rinku Patra. As a result, the consumed unit of Shri Gadtya is being recorded in his meter as well as in the meter of Shri Rinku Patra also. Such type of negligence at the end of OP is not acceptable and violates OERC Regulation. The Forum has taken this as a "SERIOUS NOTE" and directed the OP to be more vigilant while giving power supply to new consumer.

During the course of hearing, the OP admitted the fact and agreed for bill revision of Shri Rinku Patra (9110-0113-0696).

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

1. The incoming cable of Shri Lokanath Gadtya (9112-1128-0908) must be separated from the outgoing side of Shri Rinku Patra (9110-0113-0696) immediately.

2. The monthly units consumed against Shri Lokanath Gadtya (9112-1128-0908, Meter no. TWST17775534) from the date of power supply to the date of rectification is to be deducted from the bill of Shri Rinku Patra (9110-0113-0696).

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
