HISTORY OF THE CASE

The Complaint petition filed by the representative of the consumer Shri Sritam Patel who is a LT-Dom. consumer availing a CD of 2 KW. He has represented that power supply to his domestic premises was under disconnection from Jul-2013 to May-2024. He has filed his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

### PROCEEDING OF HEARING DATED: 21.01.2025

## SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under ESO-I section of Patnagarh Sub-division. The complainant represented that power supply to his premises was under disconnection from Jul-2013 to May-2024. For that, the total outstanding has been accumulated to ₹ 96,594.94p upto Dec.-2024. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant record. On defence, he intimated that the consumer is a LT-Dom. consumer availing power supply since Oct-2009. The billing dispute raised by the complainant for the false billing from Jul-2013 to May-2024 needs field verification as the matter is quite old. For that, the OP asked for seven days time to submit the report.

Considering the above, the OP requested before the Forum for revision of previous disputed SIDEX TO TO TO bills and pass order as deemed fit.

#### FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 2 KW. The consumer has availed power supply since 23<sup>rd</sup> Oct. 2009 and total outstanding upto Dec.-2024 is ₹ 96,594.94p. As complained by the complainant and submission of OP, it is observed by the Forum that,

As represented by the consumer, power supply to his premises was under disconnection from Jul-2013 to May-2024 which needs bill revision.

Against that, the OP was asked 7 day time to verify the matter and will make field inspection. The OP inspected the premises the premises on 28<sup>th</sup> Jan. 2025 and submitted the report vide ref. no. nil and certified that power supply to the consumer is active since 2009 without disconnection. Also, the complainant was unable to produce any DC & RC receipt in support of disconnection / reconnection.

The Forum analysed the documents available with the Forum and version of both the parties. It is observed that the consumer has made several payments between the year 2014 to 2024.

Details of payments are,

From the above, it is clear evidence that power supply was existing in the consumer premises. In this aspect, the inspection report dated 28<sup>th</sup> Jan. 2025 submitted by OP has taken into record.

After going through all documents, the Forum is of the opinion that there was no disconnection of power supply to the consumer premises as represented by the complainant.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The complaint of the complainant has not based on the facts. Hence, the petition of the complainant is hereby rejected.

Case is disposed off accordingly.
