#### ORDER (Dt.31.08.2024)

#### HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 2 KW. The representative of the consumer appealed before the Forum that as per GRF order in Case no. 1288/2022, the bill was revised but DPS imposed thereon was not considered for which he has filed a Case before Hon'ble High Court which was registered as case no. W.P. (C) No. 8204/2024. As per direction of Hon'ble Court dated 24<sup>th</sup> Apr. 2024, he has again approached before the Forum for revision of bill.

Considering the application of the applicant dated 10<sup>th</sup> Jul. 2024, the application was granted and registered as Case no. 447 of 2024. Accordingly, date of hearing was fixed on 30<sup>th</sup> Jul. 2024 and notice was served to both the parties on dated 18<sup>th</sup> Jul. 2024 to remain present on the said date with relevant documents.

#### **PROCEEDING OF HEARING DATED: 30.07.2024**

The OP requested before the Forum through e-mail that due to emergency breakdown of power supply, he will not able to attend and requested for a next date.

Application granted. The next date of hearing was fixed on 08<sup>th</sup> Aug. 2024. Accordingly, notice was served to both the parties on dated 30<sup>th</sup> Jul. 2024 to remain present on the said date with relevant documents.

The case was heard in detail.

# PROCEEDING OF HEARING DATED: 08.08.2024

## SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under B M Pur section of B M Pur Sub-division. The consumer represented that also though bill revision was done against GRF Case no. 1288/2022 but DPS imposed thereon has not revised. For that, the arrear has been accumulated to ₹ 1,24,284.76p upto Jul.-2024. The complainant raised dispute against non-withdrawal of DPS and requested before the Forum for suitable revision of the bill.

# SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant records. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply prior to Apr-1999. The billing dispute about non-withdrawal of DPS against arrear outstanding is genuine. Earlier, as per GRF order in Case no. 1288/2022, the bill was revised and withdrawn ₹ 4,14,284/- during Jan.-2023. But DPS against the disputed arrear was not considered for which it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

## FINDINGS AND ANALYSIS OF THE FORUM

BOLANGIR

The consumer is a LT-Dom. consumer with a CD of 2 KW. The consumer has availed power supply prior to Apr-1999 and the arrear outstanding upto Jul.-2024 is ₹ 1,24,284,.76p. As complained by the complainant and submission of OP, it is observed by the Forum that,

The complainant was earlier approached the Forum which was registered as GRF case no. 1288/2022. After hearing, the Forum passed Order on 06th Sep. 2022. Accordingly, the OP was revised the bill & withdrawn ₹ 4,14,284/- during Jan.-2023 bill but DPS imposed against the disputed arrear was not revised for which the complainant was knocked the door of Hon'ble High Court which was registered as Case no. W.P. (C) no. 8204 of 2024. After hearing, Hon'ble Court disposed the case on 24th Apr. 2024 and directed to approach concerned GRF for redressal of his grievances. As directed by Hon'ble High Court, the complainant was filed a case before the Forum and registered as 447/2024.

During the course of hearing, the OP admitted the facts stated by the complainant and intimated the Forum that after receipt of notice of the Forum, they have initiated bill revision for DPS withdrawal and an amount of ₹ 62,449.35p is to be withdrawn which is under approval of higher authority and assured that necessary sundry must be given within seven days. A copy of revised calculation of DPS was submitted during the hearing which has taken into record. Also, the complainant was convinced with the proposed withdrawal amount of ₹ 62,449.35p.

The Forum was reviewed the billing sundry and found that an amount of ₹ 62,449.35p has been reflected on 09th Aug. 2024.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code'2019.

The complaint of the complainant has already been redressed by OP & withdrawn ₹ 62,449.35p from the billing as DPS. Hence, the present case is dropped herewith.

Case is disposed off accordingly.
