ORDER (Dt.10.09.2025)

During Camp Court hearing at B M Pur Sub-division office on 21st Aug. 2025, the consumer Shri Bhakta Thanapati was present & Shri Abadhut Pradhan, Asst. Manager (Fin. & Com.) was present as opposite party.

HISTORY OF THE CASE

The Complaint petition filed by the consumer Shri Bhakta Thanapati who is LT-Dom. consumer availing a CD of 0.14 KW. He has disputed that he has not availed power supply against the above-stated consumer no. but regular bills have been served to this number which needs to be withdrawn. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED: 21.08.2025

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under ESO-B M Pur section of B M Pur Sub-division. The complainant represented that he is availing power supply against cons. no. 9152-0218-1319 but one more bill with cons. no. 9152-0218-1542 has been generated against the said connection as duplicate bill. The complainant raised dispute against the said bill and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant record. On defence, he intimated that the consumer (9152-0218-1542) is a LT-Dom. consumer availing power supply since Mar-2013. The billing dispute raised by the complainant for the duplicate billing requires field inspection for which 7 days time is required.

Considering the above, the OP requested before the Forum to allow 7 days time to make field inspection & to submit the report.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 0.14 KW. The consumer has availed power supply since 23rd Mar. 2013 and total outstanding upto Jan-2023 is ₹ 5,786.35p, thereafter no bill has been generated. As represented by the complainant and submission of OP, it is observed by the Forum that,

The complainant represented that he has availed electrical connection against cons. no. 9152-0218-1319 with a CD of 0.14 KW. In the same time, one more consumer no. 9152-0218-

1542 has been generated against the same premises.

Against that, the OP was asked 7 days time to verify the matter and will make field inspection. They had undertaken to submit a detailed report within 7 days before the Forum. The OP inspected the premises the premises on 04th Sep. 2025 and submitted the report on 08th Sep. 2025 before the Forum vide ref. no. nil and certified that the initial connection having cons. no. 9152-0218-1319 is existing and second connection having cons. no. 9152-0218-1542 has been generated wrongly and the billing needs to be stopped and withdrawn.

The Forum analysed the documents available with the Forum and version of both the parties and of the opinion to withdrawn of all bills pertaining to cons. no. 9152-0218-1542 since the date of generation of bill.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The energy bills raised to the consumer against con. No. 9152-0218-1542 is to be withdrawn from the date of generation of bill i.e. from 23rd Mar. 2013 and must be tagged with PDC category.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
