## ORDER (Dt.31.08.2024)

## HISTORY OF THE CASE

The Complainant is a LT-GPS. consumer availing a CD of 1.5 KW. He has disputed the bill tariff from Oct-Nov'2016 onwards as converted to GPS tariff. Consumer states that he is using power supply for domestic purpose from Mar-2007 but tariff has been changed from Dom to Com from Nov-2016. He has submitted his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

# PROCEEDING OF HEARING DATED: 26.07.2024

#### SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under REC Section of Sub-divisional Officer-II, Bolangir. The consumer represented that he was served bills on commercial tariff from Oct-Nov'2016 onwards although he is using power supply for domestic purpose from Mar-2007. Tariff has been changed from Dom to Com. from Oct-Nov'2016. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

#### SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with a PVR stating that consumer is using power supply for domestic purpose from date of supply which duly signed by the opposite party.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

### FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-GPS, consumer with a CD of 1.5 KW. The consumer has availed power supply since 15<sup>th</sup> Mar-2007 and the arrear outstanding upto Jun-24 is ₹.36030.55p. As complained by the complainant and submission of OP, it is observed by the Forum that,

The billing tariff of the consumer has been converted from DOM to GPS category from Oct-Nov'2016. The opposite party was unable to produce any supportive document for such change of tariff category. However, they have submitted a PVR dt.06<sup>th</sup> Aug'2024 and certified that there was no commercial establishment since the date of power supply.

After examining the documents submitted by both the parties, the Forum is of the opinion that the energy bill needs bill revision from Oct-Nov'2016 to till date under Domestic tariff.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

1. Billing tariff must be changed from GPS to Domestic from Oct-Nov'16 to till date and bills to be revised accordingly.

2. DPS is to be levied as per OERC guideline.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
