ORDER (Dt.06.09.2024)

During spot hearing at Kholan consumer camp on dt.14.08.2024 the Complainant Sri Ghatu Rana appeared before the Forum in person and also Sri Binay Kumar Panigrahi, S.D.O (Elect.), TPWODL, Titilagarh appeared in person as opposite party.

The Complainant bearing consumer no. 912133070059 in his written petition disputed the abnormal high consumption billing with 3599 units raised during the month of August'2022. He therefore requested before the Forum for redressal of his grievance by way of a suitable bill revision.

The opposite party on the other hand submitted a billing abstract concerning to the period from October'2019 to June'2024 which reveals that;

1. A meter bearing Sl. No. 540235 still exists from the date of power supply.

2. The consumer comes under Kutirjyoti category till December'2020 and later converted to domestic tariff.

3. An unit of 3599 has been gilled during the month of August'2022 which consumer disputes at present.

He also requested before the Forum to take necessary steps as deemed fit in this regard.

The Forum after going through all the relevant documents made available before the Forum observed that;

1. The meter with Sl. No. 540235 is still available in the premises of the Complainant.

2. An abnormal billing for 3599 units is seen to have been raised during August'2022 which needs to be revised.

3. The consumer has been billed on actual meter reading basis with some intermittent provisional bills which has been properly adjusted subsequently.

4. The CD of the premises is within 1.00 KW under domestic category with arrear of

Rs.20275.06ps by month ending June'2024.

The Forum is therefore of the opinion for revision of abnormal bill of 3599 units during August'2022 by way of a recasting of the energy bill consumed with the present meter.

The opposite party on the other hand has admitted the billing dispute for the above said period during hearing and initiated bill revision process on spot observing departmental guidelines. Accordingly, the monthly bills have been recalculated with the consumption by way of a recast and the petitioner was convinced with the proposed withdrawal of Rs.2148.48.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

The Forum therefore directs the opposite party to carry out the revision proposal with the proposed revised amount of Rs.2148.48ps which must be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
