ORDER (Dt.23.10.2025)

The complainant has appealed before the Forum on 16th Oct. 2025 which has been registered as Case no. 544/2025. The complainant has raised grievances about the additional bill of ₹ 14,963.80p raised in the bill of Feb-2025 and requested for bill revision. The complainant needs suitable bill revision for the said period.

Accordingly, hearing date has been fixed on 22nd Oct. 2025 and notice has served to both the parties to remain present with supportive documents on the said date.

HISTORY OF THE CASE

The Complaint petition filed by the consumer Shri Nrupa Naik who is a LT-Dom. consumer availing a CD of 2 KW. He has disputed about the additional bill of ₹ 14,963.80p raised in the bill of Feb-2025 and requested for bill revision. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED: 22.10.2025

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under ESO-IV section of Balangir-I Sub-division. The complainant represented that an additional bill of ₹ 14,963.80p has been debited in the bill of Feb-2025 illegally which needs to be withdrawn and requested before the Forum for revision of bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant records. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Jun-2008. The billing dispute raised by the complainant for the additional bill of ₹ 14,963.80p has been raised in Feb-2025 bill (for the period Jun-2021 to May-2023) in obedience to Cl-155 of OERC Dist. (Conditions of Supply) Code 2019. The reason of additional bill due to average billing made from Aug-2008 to May-2023. On 05th Jul. 2023, the defective meter has been replaced with a new meter having meter no. 300092105. After meter replacement, the monthly bills have been generated on actual basis. The additional bill of ₹ 14,963.80p has been raised based on the consumption pattern of succeeding six months and assessed for the meter defective period restricted for a period of preceding two year.

The additional bill of upward assessment has been reassessed and the reassessed amount is ₹ 13,516.12p considering succeeding twelve months average consumption and withdrawn ₹ 1,447.68p and reflected in the bill of May-2025.

Based on the above, the OP requested before the Forum to reject the complaint of complainant and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 2 KW. The consumer has availed power supply since 30th Jun. 2008 and total outstanding upto Sep.-2025 is ₹ 13,998.45p. As complained by the complainant and submission of OP, it is observed by the Forum that,

As represented by the consumer, an additional bill of ₹ 14,963.80p has been added in the bill of Feb-2025 which needs to be withdrawn. The OP submitted with relevant record that, the energy meter installed in the premises was gone defective w.e.f. Aug-2008 and continued with same status till May-2023. The OP has replaced the defective meter with a new meter on 05th Jul. 2023 with meter no. 300092105 and has been reflected in the bill. Thereafter, the monthly energy bill has been raised on actual meter reading basis. The dispute has raised for imposition of additional bill of ₹ 14,963.80p due to delay replacement of meter by the OP. Off-late, the OP has replaced the meter after four years of meter defective which violates Cl-155 of OERC Distribution (Conditions of Supply) Code-2019 and also attracts under Schedule-III of Guaranteed Standard of Performance of OERC Distribution (Conditions of Supply) Code. Hence, it is advised the OP to be more pro-active for replacement of defective meter within standard time as prescribed by Hon'ble OERC. In the instant case, the OP has exercised Cl-155 of OERC Dist. (Conditions of Supply) Code 2019.

However, the OP has re-assessed the additional bill with succeeding one year average consumption and the reassessed amount is ₹ 13,516.12p. Accordingly, an amount of ₹ 1,447.68p has been withdrawn in the bill of May-2025.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.
