ORDER (Dt.30.09.2024)

During spot hearing at Chandanbhati consumer camp on dt.22.08.2024 the Complainant Sri Rajesh Kumar Choudhury appeared before the Forum in person and also Sri Sunil Kumar Swain, S.D.O (Elect.), No. II TPWODL, Bolangir appeared in person as opposite party.

The Complainant bearing consumer no. 911225010036 in his written petition stated that although the power supply to his premises was under disconnection from the year 2011-12 but surprisingly the monthly bills have been generated with May'2023, thereby accumulation of arrear going upto Rs.126643.90ps by month ending May'2023. He therefore requested before the Forum to withdraw such bills raised during the entire period under disconnection by way of a suitable bill revision.

The opposite party on the other hand submitted a billing abstract concerning to the period from January-February'2001 to May'2023 and admitted the facts stated by the Complainant. He also produced a PVR dt.20.09.2024 along with a photo copy of the meter and statement of witness in connection with the disconnection which reveals that;

- 1. The consumer comes under domestic category with CD of 1.5 KW.
- 2. The power supply to the premises concerned was under disconnection from dt.05.03.2012 with CMR '14505' as on dt.20.09.2024.
- 3. Average bills were being raised from December'2004 to February'2010 against a meter bearing Sl. No. 1860573.
- 4. A new meter has sub subsequently been replaced having Sl. No. 344004 with actual bills being done onwards.

He also requested before the Forum to do the needful as deemed fit in this regard.

The Forum after going through all the relevant documents made available before the Forum observed that:

1. The power supply was under disconnection from dt.05.03.2012 (March'2012) with CMR '14505' as per PVR dt.20.09.2024 of the opposite party having enclosed an enquiry report with signature obtained from the local inhabitants.

Keeping all the above facts in view the Forum is the opinion for revision of bills in norms with the regulation.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

BOLANGIR W

1. All the monthly bills raised during the period of disconnection i.e. from March'2012 (dt.05.02.2012) to May'2023 are to be withdrawn.

2. A final bill must be served to the consumer considering CMR '14505' as on dt.05.03.2012.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
