# PROCEEDING OF HEARING DATED: 19.09.2024

#### SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is an Intending consumer under Sub-division-II, Bolangir. The consumer represented that he was denied new supply on the ground of arrear of a disconnected supply under chudapali section against consumer no. 911211140044.

### SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant records. On defence, he intimated that the intending consumer had a separate connection with consumer no. 911211140044 & disconnected power supply at Duanpali with arrear of Rs.30801.65

Considering the above, the OP requested before the Forum to order new supply after payment of accumulated arrear of chudapali section.

#### FINDINGS AND ANALYSIS OF THE FORUM

Sri. Meghraj Meher, Intending consumer is willing to pay arrear in name his name under Chudapali section. So new supply may be released after clearance of old arrears and observing OERC Regulation.
