ORDER (Dt.06.09.2024)

During spot hearing at Kendumundi consumer camp on dt.23.08.2024 the Complainant Sri Bhakta Gahir appeared before the Forum in person and also Sri Abanikanta Maharana, S.D.O (Elect.), TPWODL, Loisingha appeared in person as opposite party.

The Complainant bearing consumer no. 911312120498 in his written petition disputed the average billings done resulting a considerable arrear. He therefore requested the Forum to sortout his grievance and reduce the arrear by way of a suitable bill revision.

The opposite party on the other hand submitted a billing abstract concerning to the period from November'2018 to July'2024 which reveals that average basis bills have been raised during the period from October'2018 to January'2021 due to billing with defective meter. He therefore requested before the Forum to do the needful as deemed fit in this regard.

The Forum after going through all the relevant documents made available before the Forum observed that;

1. The CD of the premises is 01 KW under domestic load.

2. The arrear outstanding has gone up to Rs.18052.18ps by month ending July'2024.

3. Average bills have been done during October'2018 to January'2021 with defective meter being affixed in the premises.

4. A meter bearing Sl. No. LW395432 has been installed in the premises on 9th January 2021.

5. Subsequent bills after the meter installation are seen to have been done on actual meter reading basis till to date.

Hence, bill revision is required for the average bills concerning to the period from October'2018 to January'2021.

The opposite party agreed with the billing dispute and initiated the revision process on spot observing all departmental guidelines and an amount of Rs.12151.40ps is calculated to be withdrawn from the arrear outstanding. The Complainant was also convinced with the proposed withdrawal of Rs.12151.40ps from the arrear bill.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

The Forum therefore directs the opposite party to carry out the revision proposal with the proposed withdrawal amount of Rs.12151.40ps which must be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
