ORDER (Dt.06.09.2024)

During spot hearing at Kendumundi consumer camp on dt.23.08.2024 the Complainant Sri Seshadev Bishi appeared before the Forum in person and also Sri Abanikanta Maharana, S.D.O (Elect.), TPWODL, Loisingha appeared in person as opposite party.

The Complainant bearing consumer no. 911312120520 in his written petition disputed the average basis billing done due to defective meter. He therefore requested before the Forum to resolve the billing dispute by way of a suitable revision.

The opposite party on the other hand submitted a billing abstract concerning to the period from November'2018 to July'2024 which reveals that;

1. Average billings have been done from November'2018 to January'2021 due to unmetered supply to the premises.

2. A new meter has been installed on 12th January'2021 having SL. No. LW509735.

3. Thereafter actual billings are seen to have been done with intermittent provisional bills being duly adjusted.

He also requested before the Forum to do the needful as deemed fit in this regard.

The Forum after going through all the relevant documents made available before the Forum observed that;

1. The CD of the premises is 01 KW under domestic load.

2. The arrear outstanding has gone up to Rs.13206.09ps by month ending July'2024.

3. The monthly bills from the date of power supply i.e. from November'2018 to December'2020 have been raised without a meter and a meter is seen to have been installed during January'2021.

Hence, bill revision is required form the date of power supply i.e. dt.20.10.2018 to January'2021 after obtaining monthly average consumption of subsequent six month of the new meter with IMR '0' (IMR of January'2021) and CMR '110' (CMR of July'2021).

The opposite party admitted with the billing dispute for the above said period and during hearing he initiated bill revision process on spot observing all departmental guidelines. Accordingly, the monthly bills have been recalculated with the consumption and a net amount of Rs.10, 857.62ps is to be withdrawn from the arrear outstandings. The Complainant was also convinced with the proposed withdrawal.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

The Forum therefore directs the opposite party to carry out the revision proposal with the proposed withdrawal amount of Rs.10857.62ps which must be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
