ORDER (Dt.06.09.2024)

During spot hearing at Kendumundi consumer camp on dt.23.08.2024 the Complainant Sri Satrughan Gahir appeared before the Forum in person and also Sri Abanikanta Maharana, S.D.O (Elect.), TPWODL, Loisingha appeared in person as opposite party.

The Complainant bearing consumer no. 911312120489 in his written petition disputed the average basis bills done prior to installation of the existing meter. He therefore requested the Forum to resolve the case and reduce the arrear by way of a suitable bill revision.

The opposite party on the other hand submitted a billing abstract concerning to the period from November'2018 i.e. from the date of power supply to July'2024, which reveals that;

1. The CD of the premises is of 1.00 KW under domestic category.

2. The arrear outstanding has gone up to Rs.17145.20ps by month ending July'2024.

3. Average basis bills have been raised having without any meter during the period from October'2018 to January'2021.

4. A new meter bearing no. LW437967 has been installed in the premises on dt.10.01.2021.

He also requested before the Forum to do the needful as deemed fit in this regard.

The Forum after going through all the relevant documents made available before the Forum

1. The initial power supply appears to have been on 20th October 2018.

2. Actually average basis bills have been done from the date of power supply to January 2021.

3. A new meter is seen to have been installed during January'2021 i.e. on dt.10.01.2021 having Sl. No. LW437967.

4. Thereafter subsequent bills have been raised on actual meter reading till to date.

IDENT

In view of the above, bill revision is required for revision of bills done on average basis from October'2018 to January'2021 with IMR '0' (IMR on dt.10.01.2021) and CMR '111' (CMR of July'2021).

The opposite party admitted with the billing dispute for the aforesaid period. During hearing he initiated bill revision on spot observing departmental guidelines. Accordingly, the monthly bills has been recalculated with the consumption and a net amount of Rs.13500.16 is to be withdrawn from the arrear outstanding. The Complainant was also convinced with the proposed withdrawal of Rs.13500.16ps form the arrear.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

The Forum therefore directs the opposite party to carry out the revision proposal with the proposed withdrawal amount of Rs.13500.16ps which must be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
