#### ORDER (Dt.11.11.2025)

During Camp Court hearing at Sonepur Section office on 04<sup>th</sup> Nov. 2025, the consumer Shri Ram Chandra Pujahari was present & Shri Bibekananda Dikshit, SDO-Sonepur Sub-division was present as opposite party.

HISTORY OF THE CASE

The Complaint petition filed by the consumer Shri Ram Chandra Pujahari who is a LT-GPS. consumer availing a CD of 2 KW. The consumer represented before the Forum that earlier he availed power supply under commercial tariff but from Jun-2025, he is availing power supply under domestic tariff, but the billing category has not yet been changed still he has given application on 30<sup>th</sup> May 2025 which is pending with OP. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

## PROCEEDING OF HEARING DATED: 04.11.2025

# SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Sonepur section of Sonepur Sub-division. The consumer represented that he has availed power supply under LT-GPS tariff category till May-2025 but till date, the monthly bill is being generated on GPS category which needs to be changed under DOMESTIC tariff and needs bill revision. The complainant raised dispute with the above-stated issues and requested before the Forum to redress the grievances.

#### SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant documents. On defence, he intimated that the consumer is a LT-GPS. consumer availing power supply since Aug.-2004. Since the beginning, the consumer has availed power supply under DOM tariff till Oct-2016, thereafter under GPS tariff and continuing with same status till date. Regarding change of billing category, the consumer has approached this office on 31<sup>st</sup> May 2025 which is pending for disposal. Earlier, there was a NGO office in the name of "RARE" which was in operation from Nov-2016 to May-2025 for which bills are being raised under GPS tariff. After vacating of the said office and due to pending of application, the billing category has not yet been changed which needs to be recategorized under "DOM" tariff.

Considering the above, the OP requested before the Forum to allow 7 day time to submit the physical verification report.

#### FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-GPS. consumer with a CD of 2 KW. The consumer has availed power supply since 05<sup>th</sup> Aug. 2004 and the arrear outstanding upto Sep.-2025 is ₹ 12,893.90p. As complained by the complainant and submission of OP, it is observed by the Forum that from the date of availing power supply i.e. since 05<sup>th</sup> Aug. 2004, the consumer has availed power supply under "DOM" tariff till Oct-2016. From Nov.-2016, the billing tariff category has been reclassified under "GPS" tariff till date. The consumer disputed that he has applied with OP vide letter no. 424 dated 28<sup>th</sup> Feb. 2024 to change the billing category to "DOM" tariff as there will be no commercial from Mar-2024. The OP submitted that the said application has submitted by tenant of the premises not by the owner of the said power supply connection due to which the said application has not been considered and advised them to apply observing TPWODL guidelines. In response to that, the consumer has applied again on 30<sup>th</sup> May 2025 which is pending for disposal.

The Forum heard the submission of both the parties and of the opinion that the application for tariff change submitted on dated 28<sup>th</sup> Feb. 2024 is not a proper one as the owner of the said line has not applied and also the tenant has no proper authorization for making application. Hence, the said application is not legally tenable. The subsequent application dated 30<sup>th</sup> May 2025 submitted by the complainant has completed all departmental formalities. But it is not understood why the OP has not taken any action against that and till date it is pending with him. The Forum has taken this as a serious view and directed the OP to be pro-active for disposal of consumer grievances.

In the instant case and in accordance with Regulation of Hon'ble OERC, the complete application has been submitted by the consumer on 30<sup>th</sup> May 2025 which is to be treated as initial application for tariff change.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed to amend the billing category from GPS tariff to DOM tariff w.e.f. 01<sup>st</sup> Jun. 2025 as the first application of the complainant for tariff change has been received on 30<sup>th</sup> May 2025. Accordingly, the energy bill from 01<sup>st</sup> Jun. 2025 to till the date of category change is to be recasted under "DOM" tariff.

Case is disposed off accordingly.
