# **ORDER** (Dt.26.09.2024)

### **HISTORY OF THE CASE**

The Complainant is an intending consumer to avail supply of 2 KW. His application was held up as there is arrear outstanding in name of his father Sri Nrupa Pande amounting to Rs.37464.53 as on May-2023

The case was heard in detail.

#### PROCEEDING OF HEARING DATED: 19.09.2024

#### SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is an Intending consumer under Sub-division-II, Bolangir. The consumer represented that average bills were served after disconnection of power supply on Dt.30.09.2013 to the house in name of his father, Sri Nrupa Pande. Arrear as on Sept-13 was Rs.1386.07p.He is denied new power supply at a different location. He is willing to pay undisputed amount.

#### SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant records. On defence, he intimated that power supply was disconnected due to non payment and transformer burnt from sept-2013 and willing to withdraw subsequent avg billing.

Considering the above, the OP requested before the Forum for withdrawal of avg billing after disconnection and pass order as deemed fit.

## FINDINGS AND ANALYSIS OF THE FORUM

Sri Kunja Bihari Pande,Intending consumer is willing to pay arrear in name of his father if billing during disconnection period is withdrawn and requested to allow new **connections**. So billing upto September 2013 must be paid by Sri Kunja Bihari Pande before release of new connection.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The energy bills raised to the consumer after sept-13 is to be withdrawn and new supply be released to Sri Kunja Bihari Pande within 15 days after payment of arrear upto September'2013.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
