ORDER (Dt.30.09.2024)

During spot hearing at Tarbha consumer camp on dt.11.09.2024 the Complainant Sri Ram Narayan Ray appeared before the Forum in person and also Sri Bibekananda Dikshit, S.D.O (Elect.), TPWODL, Sonepur appeared in person as opposite party.

The Complainant bearing consumer no. 915102096817 in his written petition disputed the billings done during disconnection period from April'2012. He therefore requested before the Forum for withdrawal of such bills generated during the period of disconnection and thereby redress his grievance.

On the other hand the opposite party submitted a billing abstract concerning to the period from November-December'2011 to July'2013 having being enclosed with a photo copy of the meter and a PVR drawn on dt.11.09.2024 and admitted that there is no power supply from the date of power supply with a meter reading at '000' against meter no. LW1396319. He also requested before the Forum to do the needful as deemed fit in this regard.

The Forum after going through all the relevant documents made available before the Forum observed that;

- 1. The consumer comes under LT/ domestic category with date of power supply from dt.02.11.2011.
- 2. A meter was earlier installed in the premises with Sl. No. 819866 having average billings done from June'2014 to August'2018.
- 3. A new meter appears to have been replaced against the old one bearing no. LW139319 since dt.31.12.2018.
- 4. The arear outstanding has gone upto Rs.19675.31 by month ending July'2023.
