ORDER (Dt.30.09.2024)

HISTORY OF THE CASE

The complaint was received at Camp court conducted at Duspur on dated 12th Sep. 2024 which was registered as GRF Case no. 616/2024. Hearing date was fixed on 26th Sep. 2024. Accordingly, notice was issued both the parties to remain present on the said date with relevant documents.

The Complainant is a LT-GP. consumer availing a CD of 1.5 KW. He has disputed that he is is running a poultry firm which is to be billed under LT-Allied Agro Irr. Category but bill has been raised on GPS category. He has submitted his grievances for revision of bill under LT-Allied Agro tariff from the date of power supply. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED: 26.09.2024

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under REC section of Balangir-II Sub-division. The consumer represented that he has applied for LT-Irr. Category but bill has been generated on GPS category which needs bill revision from the date of power supply under Irrigation tariff. For that, the arrear has been accumulated to ₹ 1,510.86p upto Jul.-2024. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant documents. On defence, he intimated that the consumer is a LT-GPS. consumer availing power supply since Mar.-2009. As per PVR dated 24th Sep. 2024, the consumer is using electricity for poultry firm which is coming under Allied Agro Purpose.

Considering the above, the OP requested before the Forum to pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom, consumer with a CD of 1.5 KW. The consumer has availed power supply since 28th Mar. 2009 and the arrear outstanding upto Jul.-2024 is ₹ 1,510.86p. As complained by the complainant and submission of OP, it is observed by the Forum that,

The consumer represented that he is running a poultry firm which should be billed under LT-Allied Agro tariff but bill is served under GPS tariff which needs bill revision as per LT-Allied Agro tariff from the date of power supply.

The OP submitted a PVR report dated 24.09.2024 that, the consumer is using power supply for poultry firm purpose. The report submitted by the OP has taken into record.

The Forum analysed the documents submitted by both the parties. It is observed that the consumer was applied power supply for GPS tariff and as per prevailing OERC Regulation, power supply has been released under the said tariff. Subsequently, Allied Agro tariff has been introduced and incorporated in the OERC Regulation. In the said case, the complainant has not yet applied for change of tariff before the OP and knocked the door of this Forum for which the Forum advised the complainant to apply before the licensee for change of tariff category observing OERC Regulation.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The petition of the complainant regarding billing under LT-Allied Agro tariff is hereby rejected. The complainant is advised to apply for change of tariff category in obedience to OERC Regulation.

Case is disposed off accordingly.
