ORDER
(Dt.30.12.2025)

During spot hearing at Kholan consumer camp the Complainant Sri Mahesh Kumar Goud appeared before the Forum in person and also Sri Binay Kumar Panigrahi, S.D.O (Elect.), Titilagarh appeared as opposite party.

The Complainant bearing consumer no. 912123061696 in his written complaint dt.15.12.2025 i.e. during a GRF camp held at Kholan under Titilagarh Electrical Sub-Division, TPWODL, Titilagarh stated that exorbitant bills have been raised against him resulting accumulation of arrear to the tune of Rs.31294/- by month ending November'2025. He therefore prayed before the Forum for correction of wrong bills and reduce the arrear for payment.

The opposite party on the other hand on submission of a billing statement admitted that the earlier meter bearing no. 1852742A was detected to be defective and a new one was installed in place of the same during January'2012 where average bills were being done. However he also requested before the Forum to pass necessary order as deemed fit in this regard.

The Forum after going through the documents placed before it, observed that;

1. The CD of the premises is 2 KW load under domestic category.
2. The old defective meter bearing no. 1852742A was replaced by a new one having Sl. No. 710356 during January'2012.
3. Monthly bills on average basis have been generated during the period from December'2009 to November'2011 which needs to be revised.
4. The date of supply to the premises is dt.01.01.1990.

The opposite party admitted with the billing dispute for the above said period and during hearing initiated bill revision process on spot observing departmental guidelines. Accordingly, the monthly bills were recalculated and a net amount of Rs.671.50ps is to be withdrawn from the arrear outstanding.

The opposite party thus recalculated the bill and the Complainant was also convinced with the proposed withdrawal of Rs.671. 50ps.

Therefore, the Forum directed the opposite party to carryout the revision proposal concerning to the period from December'2009 to November'2011 with IMR '0' (IMR of January'2012) and FMR '4912' (CMR of February'2018) with a withdrawal amount of Rs.671.50ps which needs to be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
