**ORDER**  
(Dt.30.12.2025)

During spot hearing at Kholan consumer camp the Complainant Sri Kousik Behera appeared before the Forum in person and also Sri Binay Kumar Panigrahi, S.D.O (Elect.), Titilagarh appeared as opposite party.

The Complainant bearing consumer no. 912122070728 in his written complaint dt.15.12.2025 i.e. during a GRF camp held at Kholan under Titilagarh Electrical Sub-Division, TPWODL, Titilagarh disputed the average billings done leading to accumulation of a huge arrear. He therefore requested before the Forum to reduce the arrear by way of a suitable bill revision.

The opposite party on the other hand submitted a billing statement concerning to the period from February-March'2001 to November'2025 along with a written version dt.15.12.2025. The version so submitted reveals that the disputed bills have already been revised during March'2023 with adjusted amount of Rs.14611.51. Further he informed that the consumer has also availed OTS during 2022. However he requested the Forum to pass an appropriate order deemed fit in this regard.

The Forum after going through the documents placed before it, observed that;

1. The CD of the premises is 2 KW load under domestic load having date of power supply on dt.01.01.1990.
2. A meter bearing no. WESCO91282 was earlier installed in the premises which was detected to be defective and the same was replaced by a new one having Sl. No. LW022658 on dt.03.09.2018.
3. An amount of Rs.14611.51 has been withdrawn from the arrear bill during March'2023 towards delay meter updation from October'2018 to February'2023.
