ORDER
(Dt.12.03.2026)

During Camp Court hearing at Jarasingha PSS on 17th Feb. 2026, the representative of the consumer Shri Shibam Patra was present & Shri Narottam Maharana, SDO-Tusura was present as opposite party.

HISTORY OF THE CASE

The Complaint petition filed by the representative of the consumer Shri Shibam Patra who is a LT-Dom. consumer availing a CD of 1 KW. He has disputed that he has not availed power supply till date but the OP has raised false bill in his name and appealed before the Forum for withdrawal of all bills pending in his name. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED : 17.02.2026

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Deogaon Section of Tusura Sub-division. The complainant represented that he has been served with false bills from Jun-2023 to till date where he has not availed power supply. For that false bills, the arrear has been accumulated to ₹ 7,650.91p upto Jan.-2026. The complainant raised dispute against the said period and requested before the Forum for suitable revision of bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant records. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Jun.-2023. The billing dispute raised by the complainant for the false billing about no power supply period requires field verification for which seven day time may be allowed to make field verification.

Considering the above, the OP requested before the Forum to allow 7 day time to submit the physical verification report.

As committed, the OP failed to submit the required report within schedule time for which reminder has been made to OP. Finally, they have inspected the premises on 06th Mar. 2026 and submitted the report before the Forum on the same day.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 1 KW. As per record, the consumer has availed power supply since 19th Jun. 2023 and total outstanding upto Aug.-2025 is ₹ 7,650.91p, thereafter no monthly bill has been generated. As complained by the complainant and submission of OP, it is observed by the Forum that,

As per billing data, power supply to the consumer has been released on 19th Jun. 2023 but the consumer disputed that power supply to his premises has not been released till date. Against that, the OP was asked seven day time to verify the matter and will make field inspection. They were undertaken to submit a detailed report within 7 days before the Forum. The OP inspected the premises on 06th Mar. 2026 and submitted the report before the Forum and certified that power supply to the complainant has not been released till date. The inspection report dated 06th Feb. 2026 submitted by SDO-Tusura has been taken into record.

From the above, it is clear evident that power supply has not been released till date. Hence, all bills raised against the complainant needs bill revision as per OERC Regulation (Conditions of Supply) Code 2019 to redress the consumer grievances.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

1. The energy bills raised to the consumer from 19th Jun. 2023 to Aug.-2025 must be withdrawn as there was no power supply to the consumer premises.
2. The electrical connection no. 9115-2403-1133 must be kept under PDC category w.e.f. Sep.-2025 as there is no bill raised thereafter.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
