

ORDER
(Dt.30.12.2025)

During spot hearing at Kholan consumer camp the Complainant Sri Buddhadev Chhatria appeared before the Forum in person and also Sri Binay Kumar Panigrahi, S.D.O (Elect.), Titilagarh appeared as opposite party.

The Complainant bearing consumer no. 912123062733 in his written complaint dt.15.12.2025 i.e. during a GRF camp held at Kholan under Titilagarh Electrical Sub-Division, TPWODL, Titilagarh disputed the wrong billings done leading to accumulation of arrear. He therefore requested before the Forum to consider his grievance and reduce the arrear by way of a suitable bill revision.

On the other hand the opposite party submitted a billing abstract concerning to the period from September-October'2019 to November'2025 and admitted the facts stated by the Complainant. He also apprised that actually monthly bills with abnormal consumption have been raised from the date of initial power supply to November'2025. He also requested the Forum for revision of such bills as deemed fit in this regard.

The Forum after going through the documents placed before it, observed that;

1. The CD of the premises is 0.5 KW load under domestic category.
2. The date of power supply is on dt.28.08.2019.
3. The accumulated arrear by month ending November'2025 is seen to have been 5683.73.
4. A meter bearing Sl. No. 3285094 has been installed there in the premises from the date of power supply.
5. Monthly bills are being raised on actual basis with some intermittent provisional bills duly adjusted.
6. Some month with abnormal consumption are seen which need a recast.

The opposite party also admitted with the billing dispute for the above period and during hearing on spot initiated bill revision process observing departmental guidelines. The monthly bills were thus recasted from the date of meter installation and an amount of Rs.1713.20 is to be withdrawn from the arrear outstanding. The Complainant was also convinced with the revision and proposed withdrawal of Rs.1713.20ps.

Therefore, the Forum directed the opposite party to carry-out the revision proposal concerning to the period with a withdrawal amounting to Rs.1713.20ps which needs to be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
