ORDER

(Dt.30.10.2024)

HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 1 KW. He was disputed the provisional bills raised from Jan.-2017 to Jul-2017 which was not adjusted subsequently. He has submitted his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED : 21.10.2024

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Agalpur section of Loisingha Sub-division. The consumer represented that he was served with provisional bills from Jan.-2017 to Jul-2017 which was not adjusted subsequently. For that, the arrear has been accumulated to ₹ 10,569.01p upto Sep.-2024. The consumer raised dispute against the said period and requested before the Forum for suitable revision of bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant record. On defence, he intimated that the consumer is a LT-Dom. consumer availing power supply since Dec.-2008. The billing dispute raised by the complainant for the provisional billing from Jan.-2017 to Jul-2017 is a genuine dispute which needs bill revision. A new meter with sl. no. WLT018181 has been installed during Jul.-2017, thereafter actual billing was done. As the above-stated period bill has not revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 1 KW. The consumer has availed power supply since 15th Dec. 2008 and the total outstanding upto Sep.-2024 is ₹ 10,569.01p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. As represented by the representative of the consumer, due to erroneous provisional billing, he was served with provisional bills from Jan.-2017 to Jul.-2017 which needs bill revision.

The OP admitted the complaint and submitted that a new meter has been installed with meter no. WLT018181 during Jul-2017 and thereafter actual billing has been done. The provisional billing period needs bill revision as per consumption of new meter.



During the course of hearing, the OP has admitted with the billing complaints and initiated bill revision process on the spot observing departmental guidelines. Accordingly, the monthly bill has been recalculated with the consumption and an amount of ₹ 3,587.38p is to be withdrawn from the arrear outstanding.

2. The complainant has not paid the monthly bill regularly for which the total outstanding has been accumulated to ₹ 10,569.01p upto Sep.-2024.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP was agreed with the billing dispute and revised the bill on spot and the petitioner was convinced with the proposed withdrawal amount of ₹ 3,587.38p. Hence, the Forum directed the OP to carry-out the revision proposal and must be reflected in the next bill.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
