ORDER (Dt.28.02.2025)

During hearing at GRF office on 20th Feb. 2025, the consumer as well as complainant Shri Govinda Mishra was present & Shri Bibekananda Dikshit, SDO-Sonepur was present as opposite party.

HISTORY OF THE CASE

The Complaint petition filed by the consumer Shri Govinda Gopal Mishra who is a LT-Dom. consumer availing a CD of 0.14 KW. He has disputed about the additional bill of ₹ 17,014.08p raised in the bill of Oct-2024 and requested for bill revision. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED: 20.02.2025

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Tarbha section of Sonepur Sub-division. The complainant represented that an additional bill of ₹ 17,014.08p has been debited in the bill of Oct-2024 illegally which needs to be withdrawn and requested before the Forum for revision of bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING


The OP appeared before the Forum with relevant records. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Jan.-2016. The billing dispute raised by the complainant for the additional bill of ₹ 17,014.08 has been raised in obedience to Cl-155 of OERC Dist. (Conditions of Supply) Code 2019 which is liable to pay by the consumer. The reason of additional bill due to average billing from Aug-Sep/2018 to Sep-2023. On 08th Sep. 2023, the defective meter has been replaced with a new meter having meter no. TWSP51042177. After meter replacement, the monthly bills have generated on actual basis. The additional bill of ₹ 17,014.08p has been raised based on the consumption pattern of succeeding six months and assessed for the meter defective period restricted to preceding two year i.e. from Sep-2021 to Aug-2023.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 0.14 KW. The consumer has availed power supply since 11th Jan. 2016 and total outstanding upto Jan.-2025 is ₹ 23,051.09p. As complained by the complainant and submission of OP, it is observed by the Forum that,

1. As represented by the consumer, an additional bill of ₹ 17,014.08p has been added in the bill of Oct-2024 which needs to be withdrawn.

The OP submitted by OP with relevant record that, the energy meter installed in the premises with meter no. 4686197 since the date of power supply was gone defective w.e.f. Aug-Sep/2018 and continued with same status till Sep-2023 billing. The OP has replaced the defective meter with a new meter on 08th Sep. 2023 with meter no. TWSP51042177 and has been reflected in the bill. Thereafter, the monthly energy bill has been raised on actual meter reading basis. The dispute has raised for imposition of additional bill of ₹ 17,014.08p due to delay replacement of meter by the OP. Off-late, the OP has replaced the meter after five years of meter defective, it is advised the OP to be more pro-active for replacement of defective meter within standard time as prescribed by Hon'ble OERC. In the instant case, the OP has exercised Cl-155 of OERC Dist. (Conditions of Supply) Code 2019.

2. The complainant has not paid the monthly bill regularly for which the total has been accumulated to ₹ 23,051.09p upto Jan.-2025.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The additional bill of ₹ 17,014.08p has been raised by the opposite party is in obedience to Cl-155 of OERC Dist. (Conditions of Supply) Code, 2019 and the complainant is liable to pay the same. Hence, the complaint of the complainant is hereby rejected. The Forum advised the OP to allow suitable installment on the additional bill to the complainant if the complainant desires and the complainant has to adhere the same.

Case is disposed off accordingly.
