## Complaint Case No. BGR/802/2024

## ORDER (Dt.27.02.2025)

During hearing on dt.09.01.2025 the Complainant Smt. Snigdha Rani Sarangi appeared before the Forum in person whereas Sri Swadhin Sahu, OAG-II, Electrical Sub-Division, No. I, TPWODL, Bolangir appeared as authorised representative of opposite party.

The Complainant in her written petition dt.27.12.2024 stated that she had applied for a new service connection (domestic power supply) to her plot at Satyanarayanpada (near Sonalika Tractor Show Room) on deposit of prescribed fees on dt.29.05.2023 which was kept on hold by the licensee. She therefore requested before the Forum to issued necessary direction to the opposite party for release of power supply which has inordinately been delayed.

The Complainant was found present during hearing on dt.09.01.2025 whereas on the other hand the opposite party submitted a written version which reveals that the Complainant Smt. Snigdha Rani Sarangi had applied for new connection under LT (domestic) tariff with CD of 02 KW on deposit of required fees. But the same was held up for pending arrear of Rs.62931.57 along with a penal amount of Rs.24405.00 against consumer number 911124140147 in the name of Sri Shyama Sundar Sarangi where the premises is the same where the said arrear still exists unpaid. However, the opposite party could not produce the revenue records with land details to prove that the plot for which service connection is applied, exists in the same premises.

However, the Complainant on her defence stated that she occupies a portion of land earlier owned by her grand father-in-law and at present intends to construct a residence house although the ownership lies with the Government. Thus she could neither produce a legal heir certificate as a bonafied share holder of the plot nor any documentary evidence towards making any application to the revenue authority for recording the Govt. plot in her name as the rightful owner being the only surviving widow lady and a share holder of the land (premises).



However, the hearing was adjourned to dt.05.02.2025 with a speaking order to the Complainant to produce a legal heir certificate as a token of proof as the rightful share holder of the premises and the opposite party to show documentary evidence as regards to the premises in question where the arrear exists. But since the Complainant could not make herself available during hearing on dt.05.02.2025 it was further adjourned to dt.20.02.2025.

During hearing on dt.20.02.2025 the Complainant Smt. Snigdha Rani Sarangi appeared before the Forum in person whereas Miss. Reenarani Sahoo, OAG-II, Electrical Sub-Division, No. I, TPWODL, Bolangir appeared as authorised representative of opposite party.

During hearing on dt.20.02.2025 the Complainant still could not produce a legal heir certificate but the opposite party showed a videographic evidence that the plot of the Complainant exists in the same premises where the service connection is applied but having an arrear there on.



- 1. As per rule 16(1) of the OERC Distribution (Conditions of Supply) Code 2019 the premises where the Complainant applied for new service connection is in arrear of electricity dues for the same premises, the application for new power supply could not be allowed until the arrear is settled.
- 2. The Complainant also could not produce a legal heir certificate as a token of rightful owner/share holder of the premises/ on the undivided property (land) to avail the new service connection on prorota payment basis on total arrear existing on the premises as per rule 16(3).

The Forum is therefore of the opinion to reject the Complainant of the Complainant having no merit in the case.

The Complaint of the Complainant is hereby rejected.

Case is disposed off accordingly.
