## ORDER (Dt.28.02.2024)

During spot hearing at Dubula consumer camp on dt.05.02.2024 the Complainant Sri adeep Kumar Mishra appeared before the Forum in person and Sri Bibekananda Dikshit, S.D.O (Elect.), TPWODL, Sonepur also appeared as opposite party.

The Complainant bearing consumer no. 915103070123 disputed the bills raised on GP tariff although the power supply is being utilised in domestic purpose. He therefore requested before the Forum to look into his grievance and settle it by a suitable bill revision.

The opposite party on the otherhand submitted a billing abstract concerning to the period from January-February'2001 to January'2024 and also requested the Forum to do the needful as deemed fit in this regard.

The Forum after going through the records placed before it, observed that;

- 1) Power supply is seen to have been without any meter during the period from January'2001 to December'2002.
- 2) A meter with Sl. N o. 150625 appears to be in use during the period from January'2003 to February'2004.
- 3) Thereafter the above meter has been replaced with a new one having Sl. No. 1861201 with average basis bill till October'2015.
- 4) An another meter bearing no. WCG22394 is seen to be replaced and in use since November-December'2015 to todate which is running ok.
- 5) The bills have been raised on GP tariff from November-December'2017.

The Forum during hearing advised the opposite party to produce necessary certification for change of tariff/ category to which he did not pay any heed at all, for that the Forum feels that the power supply is being utilised for domestic purpose from Complainant's version during hearing.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

The energy bills from March'2024 is to be raised under domestic category safter observing all departmental guidelines.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
