HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 1 KW. He has disputed that the erroneous bill was revised during Sep-2022 but the DPS levied on the erroneous bill has not yet revised. He has submitted his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

#### PROCEEDING OF HEARING DATED: 20.11.2023

#### SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Tureikela Section of Kantabanji Sub-division. The consumer represented that his erroneous bill was revised in Sep-2022 but the DPS imposed on the erroneous bill has not yet withdrawn. For such, the arrear has accumulated to ₹. 20,267.51p upto Oct-2023. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

## SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with billing ledger. On defence, he intimated that the consumer is a LT-Dom consumer availing power supply since Apr.-2021. The billing dispute raised by the complainant for the DPS imposed on the arrear amount is genuine. The disputed erroneous bill has been revised in Sep-2022 with EC: ₹. 69,344.16p & ED: ₹. 2,773.77p totaling of ₹. 72,117.93p. As the bill for the above above-stated DPS period has not yet revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

### FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 1 KW. The consumer has availed power supply since 20<sup>th</sup> Apr. 2021 and the arrear outstanding upto Oct-2023 is ₹. 20,267.51p. As complained by the complainant and submission of OP, it is observed by the Forum that,

- Due to wrong punching of meter reading in Jan-2022 bill, 7939 units of bill was raised amounting to ₹. 44,045.49p. The OP has revised the said erroneous bill in Sep-2022 on withdrawal of 6706 units amounting ₹. 72,117.93p (EC: ₹. 69,344.16p & ED: ₹. 2,773.77p). But the DPS levied on the said erroneous bill from Jan-2022 to 27.09.2022 (bill revision date) has not been withdrawn which needs bill revision.
- 2. The OP has submitted that as the disputed DPS billing period has not yet revised, it needs bill revision as per payments received.
- 3. On scrutiny of the documents, it is observed by the Forum that the DPS levied during the billing period Jan-2022 to 27.09.2022 needs bill revision under Cl-155 of OERC Distribution Code-2019 to redress the consumer grievances.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

- 1. The DPS levied from Jan-2022 to 27.09.2022 is to be recasted with the revised bill and payment received during that period and accordingly bill revision is to be done.
- 2. All sundries and adjustments are to be considered during the above revision period.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
