ORDER (Dt.28.02.2024)

During hearing on dt.15.02.2024 the Complainant Sri Daya Sagar Sunani appeared before the Forum in person whereas Sri Kailash Chandra Swain, DM (F&C), TED, TPWODL, Titilagarh appeared as opposite party on behalf of EE, TED, TPWODL, Titilagarh.

The Complainant bearing consumer no. 912001021403 in his written petition dt.06.02.2024 i.e. during a GRF camp held at Mandal under Belpada section of Patnagarh sub-division stated that;

- a. Money receipt of Rs.5000/- against receipt no. A94143189 dt.31.08.2016 has not been credited to his account.
- b. Despite a single point power supply an another bill with consumer no. 912001024189 is being generated which requires to be stopped forthwith.

He therefore requested before the Forum to redress his grievance by way of an appropriate bill revision.

The opposite party admitted to the facts so stated by the Complainant and submitted a PVR with a written version dt.12.02.2024 along with a billing abstract concerning to the period from April'2018 to January'2024 which indicates that;

1) The consumer comes under Irrigation category with CD of 2.5 KW.

2) The amount of Rs.5000/- has actually been not credited as paid on dt.31.08.2016.

3) An additional bill against the same consumer has wrong been generated with a different account number will also be taken care of.

The Forum after going through all the records placed before it and the version stated by the opposite party is of the opinion for due credit of the misposting done and to stop the additional bill so raised.

Basing on above observations, Forum passes the following direction as per Regulation of OERC Distribution (Conditions of Supply) Code 2019.

1) The payment of Rs.5000/- made on dt.31.08.2016 vide M.R. No. A9/4143189 and Rs.2000/- paid by the Complainant against fake consumer no. 912001024189 is to be duly credited to his account immediately.

2) The additional duplicate gill which are being raised against the Complainant with consumer

no. 912001024189 are to be stopped forthwith.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
