HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 0.5 KW. He has disputed about the average bills raised from Aug-2021 to till date due to meter defective. He has submitted his grievances for revision of bill and installation of new meter. The complainant needs suitable bill revision for the said period.

The case heard in detail.

PROCEEDING OF HEARING DATED: 08.12.2023

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Khaprakhhol Section of Patnagarh Sub-division. The consumer represented that he was served with average bills from Aug-2021 onwards to till date due to meter defective. For such average bill, the arrear has accumulated to ₹. 4,368.22p upto Nov.-2023. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with billing abstract only. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Nov.-2016. The billing dispute raised by the complainant for the average billing from Aug-2021 to till date due to meter defective. As the above-stated average billing period bill has not been revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 0.5 KW. The consumer has availed power supply since 22nd Nov. 2016 and the arrear outstanding upto Nov.-2023 is ₹. 4,368.22p. As complained by the complainant and submission of OP, it is observed by the Forum that,


1. Due to meter defective, the consumer is billed with average bills from Aug-2021 to till date with meter no. A5448176 resulting accumulation of arrear outstanding. Till date, the defective meter has not been replaced.
2. In the instant case, it is surprised that the OP has allowed the consumer to continue with defective meter for more than two years. In the above case, due to delay in installation of new meter, average billing has been done which could have been avoided if the OP has installed the meter without delay for which it is advised to the OP to be taken care in future.
3. During the course of hearing, the Forum directed the OP to submit a PVR with meter status within seven days but the OP fails to submit within stipulated time. Again, reminder was given to submit without further delay but till date the OP fails to comply the direction of the Forum for which it is construed that the OP has nothing to say in this regard and the matter is to be decided as per available documents.
4. The OP has submitted that as the disputed billing period has not yet revised, it needs bill revision as per consumption of new meter.
5. On scrutiny of the documents, it is observed by the Forum that the bills raised during meter defective period needs bill revision under CI-155 and 157 of OERC Distribution Code-2019 to redress the consumer grievances.


In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

1. A new meter is to be installed immediately as per Reg-116 of OERC Dist. (CoS) Code 2019 to ascertain the consumption of the consumer as well as proper billing.
2. The energy bills raised to the consumer is to be revised from the date of meter replacement to the preceding two years as per average of six consecutive billing of new meter under CI-155 & 157 of OERC Distribution Code 2019.
3. DPS is to be levied as per OERC Regulation.
4. All sundries and adjustments are to be considered during the above revision period.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within seven months after receipt of GRF order otherwise it will be treated as non-compliance.
