HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 1 KW. He has disputed the penalty bill of ₹. 1,23,971/- against the inspection made on 07th Aug. 2023. The complainant needs waival of the said penalty bill.

The case was heard in detail.

PROCEEDING OF HEARING DATED: 28.12.2023

During the said date of hearing, the complainant was not present whereas the authorized representative of the OP (Sh. Kailash Ch. Swain, DFM (F & C), Titilagarh division) requested before the Forum by e-mail to fix another date as he is unable to be present due to his health issue.

Considering his submission, the next date of hearing was fixed on 10th Jan. 2024 at Bangomunda Camp Court. Accordingly, notice was issued to both the parties.

PROCEEDING OF HEARING DATED: 10.01.2024

The case was heard in detail.

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Turekela Section of Kantabanji Sub-division. The consumer represented that he was served with a penal bill of ₹. 1,23,971/- against the inspection made on 07th Aug. 2023 where he has availed the power supply through a meter no. 5220384. The complainant raised dispute against the said penal bill and requested before the Forum for waival.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant documents. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Dec-2006. The complaint raised by the complainant for the penalty raised against un-authorised use of electricity by means of direct hooking from the nearby LT pole and used for GPS category which was detected on 07th Aug. 2023 against registration no. 744807082304.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

OBSERVATIONS OF THE FORUM

The consumer is a LT-Domestic consumer with a CD of 1 KW. The arrear outstanding as on Dec-23 is ₹. 10,745.34p. As complained by the complainant and submission of OP, it is

observed by the Forum that,

1. The dispute raised for penal bill of ₹. 1,23,971/- against the inspection report dated 07th Aug. 2023 vide registration no. 744807082304. The complainant's is view that he was availing power supply against his new service connection ref. no. TPW10278825 in the name of Rajesh Kumar Jain for domestic tariff through meter no. 5220384 where as the OP submitted that the said meter is not a departmental meter and the consumer availed power supply through direct hooking from the nearby LT pole and used for GPS purpose.

2. From the documents submitted by both the parties, it is seen that the said case relates to imposition of penal bill for unauthorised use of electricity. As the penal bill part is not coming under the purview of GRF, the Forum has nothing to do in this regard. The complainant is hereby advised to appeal before the appropriate authority for this

dispute.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The dispute regarding imposition of penalty is not coming under the purview of GRF. Hence, the present case is rejected herewith.

Case is disposed off accordingly.
