ORDER (Dt.29.01.2024)

During 2nd hearing on dt.11.01.2024 the Complainant Sri Lokanath Bag did not appear before the Forum whereas Sri Kailash Chandra Swain, DFM, TED, Titilagarh appeared as authorised representative of opposite party. The 1st hearing done on dt.28.12.2023 was postponed due to absence of both parties.

The Complainant bearing consumer no. 9120 0103 2219 being the Chairman of Greem Park LI point, Mahada-II in his written petition stated that the above LI point was under defunct condition from the date of power supply being effected with flood water during 2009-2010. But the bills are being generated till date. He also enclosed a letter bearing no. 685 dt.15.11.2023 issued by the District Manager, Odisha Agro Industries Corporation Ltd., Bolangir which authenticates that the aforesaid LI project executed during 2009-2010 was found defunct since long. He therefore requested before the Forum for waiving out the bill raised till date.

The opposite party submitted a written version dt.08.01.2024 which reveals that;

- 1. The CD of the consumer is 7.5 KW under LI category.
- 2. The consumer was being billed on provisional and average basis from the date of power supply to November'2023.
- 3. A new meter with Sl. No. 10053709 has been replaced on dt.22.12.2023 and the date of power supply being dt.31.12.2016.
- 4. As per PVR of JE, Titilagarh No. II power supply to the premises was not availed since March'2019.
- 5. The bills have already been revised form the period from September'2021 to October'2023 on withdrawal of Rs.31183.52 during December'2023 and another bill for March'2023 having duly credited to the consumer's account for Rs.2079.97.

6. The consumer has already paid Rs.15000/- on dt.19.12.2023.
