HISTORY OF THE CASE

The Complainant is a LT-Dom. consumer availing a CD of 1 KW. He has disputed the inflated bill raised in Nov-2023 with 11845 units. He has submitted his grievances for revision of l. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

PROCEEDING OF HEARING DATED: 09.02.2024

SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under ESO-II section of Titilagarh Sub-division. The consumer represented that he was served with inflated bill in Nov-2023 with 11845 units. For such, the arrear has accumulated to ₹. 76,051.50p upto Jan.-2024. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with billing abstract. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Feb.-2018. The billing dispute raised by the complainant for the inflated billing done in the month of Nov-2023 with 11845 units is genuine. This has happened due to suppressed meter reading done by concerned meter reader to prevent actual billing in the previous months. After receipt of compolaint, he has revised the bill for the period from Feb-20218 to Nov-2023 and withdrawn ₹. 18,582.01p and credited in the bill of Jan-2024.

Considering the above, the OP requested before the Forum to pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 1 KW. The consumer has availed power supply since 01st Feb. 2018 and the arrear outstanding upto Jan-2024 is ₹. 76,051.50p. As complained by the complainant and submission of OP, it is observed by the Forum that,

- 1. Due to supressed meter reading by the concerned meter reader in the preceding month, the consumer was billed less units than his actual consumption. This has been identified in the month of Nov-2023 billing and the unbilled units has been billed in the said month. Due to such bill, the arrear amount has accumulated.
- 2. The complainant has not paid the monthly bill regularly for which the arrear has accumulated to ₹. 76,051.50p upto Jan.-2024.
- 3. During the course of hearing, the OP intimated that they have revised the disputed bill in Jan-2024 and withdrawn ₹. 18,582.01p in the bill of Jan-2024. The revision period involves from Feb-2018 to Nov-2023.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

The OP has revised the bill in Jan-2024 and withdrawn ₹. 18,582.01p from the bill. As the grievances of the consumer was properly addressed by OP and the dispute has resolved, the present case is dropped.

Case is disposed off accordingly.
