# ORDER (Dt.27.02.2024)

### **HISTORY OF THE CASE**

The Complainant is a LT-Dom. consumer availing a CD of 1 KW. He has disputed the inflated bill raised in Aug-2022 with 1215 units. He has submitted his grievances for revision of bill. The complainant needs suitable bill revision for the said period.

The case was heard in detail.

## PROCEEDING OF HEARING DATED: 12.02.2024

## SUBMISSION OF COMPLAINANT DURING HEARING

The complainant is a consumer under Muribahal section of Kantabanji Sub-division. The consumer represented that he was served with inflated bill in Aug-2022 with 1215 units. For such, the arrear has accumulated to ₹. 5,855.46p upto Jan.-2024. The complainant raised dispute against the said period and requested before the Forum for suitable revision of the bill.

## SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum without relevant documents. On defence, he intimated that the consumer is a LT-Domestic consumer availing power supply since Dec.-2020. The billing dispute raised by the complainant for the inflated billing done in the month of Aug-2022 with 1215 units is genuine. This has happened due to suppressed meter reading done by concerned meter to prevent actual billing in the previous months. As the above-stated period bill has not been revised, it needs bill revision.

Considering the above, the OP requested before the Forum for revision of previous disputed bills and pass order as deemed fit.

FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 1 KW. The consumer has availed power supply since 13<sup>th</sup> Dec. 2020 and the arrear outstanding upto Jan-2024 is ₹. 5,885.46p. As complained by the complainant and submission of OP, it is observed by the Forum that,

- 1. Due to supressed meter reading by the concerned meter reader in the preceding months, the consumer was billed less units than his actual consumption. This has been identified in the month of Aug-2022 billing and the unbilled units has been billed in the said month. Due to such bill, the arrear amount has accumulated.
- 2. The complainant has not paid the monthly bill regularly for which the arrear has accumulated to ₹. 5,855.46p upto Jan.-2024.
- 3. The OP has submitted that as the disputed billing period has not yet revised, it needs bill revision as per consumption of new meter.
- 4. On scrutiny of the documents, it is observed by the Forum that the bills raised during meter defective period needs bill revision under Cl-155 & 157 of OERC Dist. (Conditions of Supply) Code 2019 to redress the consumer grievances.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

- 1. The energy bills raised to the consumer from date of supply i.e. 15<sup>th</sup> Dec. 2020 to Aug-2022 are to be revised as per actual meter reading by way of recasting by considering IMR: 0 (13.12.2020) & FMR: 2178 (Aug.-2022) under Cl-155 & 157 of OERC Dist. Code 2019.
- 2. DPS is to be levied as per OERC Regulation.
- 3. All sundries and adjustments are to be considered during the above revision period.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
