The Complainant is a LT-Dom. consumer availing a CD of 2 KW_. He has disputed meter rent though cost of meter has been paid in full and submitted photocopy of money receipt amounting to Rs.1711=00, vide MR No-34741013022302020001, Dt.13.02.23. Meter rent for the period Jan-23 to Jan-24 @ Rs.40=00 per month claimed by OP need to be withdrawn.

SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant document. He intimated that consumer complaint of claim of meter is due to improper entry in consumer ledger and agreed to withdraw if ordered by Forum.


FINDINGS AND ANALYSIS OF THE FORUM
