### ORDER (Dt.30.03.2024)

### HISTORY OF THE CASE

The Complainant is a LT-Dom consumer availing a CD of 2 KW\_. He has disputed abnormally high billing from Jun-22 to Sept-22 due to jumping of meter readings. Meter changed in Oct-22 and running OK.

#### PROCEEDING OF HEARING DATED: 14/03/2024

#### SUBMISSION OF COMPLAINANT DURING HEARING

The Complainant is a LT-Dom. consumer availing a CD of 2 KW\_. He has disputed abnormally high billing from Jun-22 to Sept-22 due to jumping of meter readings. Meter changed in Oct-22 and running OK. SDO No-I, Bolangir submitted PVR stating that earlier meter having Sl. No-108212 became defective from Jun-22 and readings jumped abnormally.

# SUBMISSION OF OPPOSITE PARTY DURING HEARING

The OP appeared before the Forum with relevant document. SDO No-I, Bolangir submitted PVR stating that earlier meter having Sl. No-108212 became defective from Jun-22 and readings jumped abnormally. Meter was replaced in the month of Oct-22 and new meter Sl. No-TPWODL 1089835 is functioning OK having CMR=1237 as on Dt.06.03.24.

#### FINDINGS AND ANALYSIS OF THE FORUM

The consumer is a LT-Dom. consumer with a CD of 2KW. As complained by the complainant and submission of OP, it is observed by the Forum that, earlier meter shown wrong readings from Jun-22 and billings from June-22 to sept-22 need revision.

In view of above facts and circumstances and after going through the documents submitted by both the parties, the Forum pronounces the following order as per regulations of the OERC Distribution (Conditions of Supply) Code 2019.

1. The energy bills raised to the consumer from Jun-2022 to Sept-2022 are to be revised as per succeeding six months average consumption of new meter under Cl-155 & 157 of OERC Distribution Code 2019.

2. DPS is to be levied as per OERC Regulation.

3. All sundries and adjustments are to be considered during the above revision period.

Case is disposed off accordingly.

Compliance report must be submitted to the Forum by the opposite party within one month after receipt of GRF order otherwise it will be treated as non-compliance.
