

During hearing on dt.14.03.2024 the Complainant Sri Bipul Kumar Sahu appeared in person whereas Smt. Sita Rani Seth, Jr. Accountant appeared as authorised representative of opposite party.

The Complainant bearing consumer no. 911211140541 in his written petition stated that the consequential revision as per GRF order in case no. 958/2023 has not properly been executed where his grievance still remains unresolved. He therefore requested before the Forum for examination of the revision done by the opposite party.

The opposite party submitted a statement following revision of bills from dt.21.06.2020 to dt.31.08.2023 with debit sundry of Rs.52281.45 done by the corporate office but the Complainant does not agree to this and opposite party also could not convince the Forum in this regard.

The case was therefore adjourned to dt.21.03.2024.

During 2<sup>nd</sup> hearing on dt.21.03.2024 the Complainant Sri Bipul Kumar Sahu appeared in person whereas Smt. Sita Rani Seth, Jr. Accountant appeared as authorised representative of opposite party and in readiness to contest their stand for proper execution of order passed by the Forum in case no. 958/2023. The Complainant however submitted that he has installed a solar in the premises for use from dt.03.06.2021.

The opposite party keeps its stand as per the similar written version submitted in the last hearing on dt.14.03.2024. The version implies that the debit sundry was earlier assessed during August'2023 and calculated to be Rs.52281.45 consequential to revision pertaining to the period from dt.21.06.2020 to dt.31.08.2023. Subsequently, as per GRF order in case no. 958/2023, the

energy bill revised and revised amount comes to Rs.45374.47. Accordingly the differential amount of Rs.6906.98 (Rs.52281.45-Rs.45347.47) has been withdrawn from consumer's account on October'2023 bill.

The Forum after examination of the revision statement finds that the arrear outstanding of Rs.49426.91ps shown in the bill of February'2024 is in obedience to OERC Regulation.

Basing on above observations, Forum passes the following direction as per Regulation of DERC Distribution (Conditions of Supply) Code 2019.

The arrear amount of Rs.49426.91ps appears in the bill of February'2024 is in obedience to OERC Regulation Code is correct and to be cleared up by the Complainant.

Case is disposed off accordingly.
